## **GENERAL BUSINESS**

St. Dominic Jackson Memorial Hospital requested the Board grant a waiver for the requirements of Article VII Responsibility of Pharmacist-in-Charge, specifically, that the Board allow a single pharmacist to serve as the PIC for each of the permitted sites that are serviced by the St. Dominic's Central Pharmacy. St. Dominic also requested that the requirement for the PIC to be present for 20 hours per week or 50% of the hours of operation be waived for certain permits operated by St. Dominic. The Board voted to deny the request for a single pharmacist to be PIC at each of the permitted facilities operated by St. Dominic but to allow St. Dominic six months to appoint a separate PIC for each of the permits operated by St. Dominic. The Board granted a waiver for the 20 hours/50% operation requirement for the permits that are nothing more than dispensing cabinets. Board members Todd Barrett, Jillian Foster, Guy Phillips and Tony Waits voted in favor of the action. Board members Ronnie Bagwell, Larry Calvert and Ryan Harper voted against the action.

Quenisha J. Conway, Pharmacy Technician Registration Number PT-221719, is alleged to have committed the following violation:

Mississippi Board of Pharmacy Administrative Rules, Rule 2.1 O:

**The theft or embezzlement of prescription drugs, controlled substances, medical devices, or funds from a permitted facility.**

Specifically, Quenisha J. Conway, Pharmacy Technician Registration Number PT-221719, admitted to the theft of controlled substances from the Walgreens pharmacy where she worked. Conway surrendered her pharmacy technician registration on June 16, 2021.

FINDINGS OF FACT

#### JURISDICTION

The Mississippi Board of Pharmacy has jurisdiction of the subject matter and person of D & B Discount Drugs, Inc., Permit to Operate as a Pharmacy, Permit Number 01593/1.1, pursuant to Section 73-21-97 (1)(f), Mississippi Code of 1972, Annotated.

#### STATEMENT OF CHARGES

D & B Discount Drugs, Inc., Permit to Operate as a Pharmacy, Permit Number 01593/1.1, is alleged to have committed the following violations:

Mississippi Pharmacy Practice Regulations Article IX ACTION AGAINST PERMITS, Paragraph 1, B:

1. The Board of Pharmacy may refuse to issue or renew, or may suspend, summarily suspend, place on probation, revoke, reprimand, or restrict the permit of any permitted facility and/or impose a monetary penalty upon one or more of the following grounds:
  - B. Any act by any person in the conduct of the activities of the facility which is a violation of the rules and regulations of the Board of Pharmacy.

Mississippi Pharmacy Practice Regulations Article VII RESPONSIBILITY OF PHARMACIST-IN-CHARGE (PIC):

1. The person who signs the application for a pharmacy permit or the renewal of a pharmacy permit shall be the pharmacist-in-charge (PIC) for that facility.
  - A. Authority. The PIC of the pharmacy shall be responsible for complete supervision, management and compliance with all federal and state pharmacy laws and regulations pertaining to the practice of pharmacy in the entire prescription department. He/She shall have the cooperation and support of all pharmacy staff in carrying out these responsibilities. The pharmacist-in-charge is responsible for assuring that all personnel are properly registered or licensed with the Board and that all pharmacy permits are current and appropriate for the type of pharmacy operation being conducted. A pharmacist shall not be the PIC at more than one Community Pharmacy or Institutional I Pharmacy (unless the Board grants a waiver upon presentation of good



cause) and shall not be the pharmacist-in-charge or have personal supervision of more than one facility which is open to the general public on a full-time basis.

Specifically, April M. Miller, License to Practice Pharmacy, Certificate of Registration Number E-010200, is the pharmacist-in-charge of D&B Discount Drugs, Pharmacy, Permit #01593/1.1. The pharmacy technician registration of Megan Moss (PT 221780) expired March 31, 2020. Megan Moss continued to perform pharmacy technician duties while her pharmacy technician registration was expired. As the pharmacist-in-charge, Miller was responsible for assuring that all pharmacy technicians were properly registered.

Mississippi Pharmacy Practice Regulations Article XII PRESCRIPTION/ORDER REQUIRED AND REFILL AUTHORIZATION/RECORDKEEPING:

1. Prescription drugs shall be dispensed only pursuant to a valid prescription or a valid order. A pharmacist shall not dispense a prescription which the pharmacist knows or should know is not a valid prescription. A Prescription Drug Order, to be effective, must be issued for a legitimate medical purpose by a Practitioner acting within the course of legitimate professional practice.  
A Prescription Drug Order shall contain the following information at a minimum:
  - (1) full name and street address (if required by law) of the patient;
  - (2) name, address, and, if required by law or rules of the Board, DEA registration number of the prescribing Practitioner;
  - (3) date of issuance;
  - (4) name, strength, dosage form, and quantity of Drug prescribed;
  - (5) directions for use;
  - (6) refills authorized, if any;
  - (7) if a written Prescription Drug Order, prescribing Practitioner's signature;
  - (8) if an electronically transmitted Prescription Drug Order, prescribing Practitioner's electronic or digital signature;
2. A Prescription Drug Order must be communicated directly to a Pharmacist, or when recorded, in such a way that the Pharmacist may review the Prescription Drug Order as transmitted. A prescription/order may be accepted by a pharmacist in written form, orally, or electronically unless the order is for a Schedule II controlled substance (refer to ARTICLE XIX) of these regulations. Electronically transmitted prescription drug orders shall meet the following requirements:
  - A. Electronically transmitted prescription drug orders shall meet the following criteria:
    - (1) be transmitted only to the pharmacy of the patient's choice; and
    - (2) be transmitted by an authorized Practitioner or his or her designated agent provided that the identity of the transmitting agent is included in the order; and
  - B. Prescription drug orders transmitted by facsimile or computer shall include:
    - (1) The complete name, address, and DEA Registration Number of the practitioner if required;
    - (2) The transmitters telephone number or any other suitable means to contact the transmitter for verbal and/or written confirmation;
    - (3) The name, address, and age of the patient;
    - (4) The time and date of the transmission; and,
    - (5) The full name of the person transmitting the order; and



- (6) The identity of the Pharmacy intended to receive the transmission, as well as any other information required by federal or state law.
- C. An electronically transmitted drug order which meets the requirements of this ARTICLE shall be deemed the original order.
- D. The pharmacist shall exercise professional judgment regarding the accuracy, validity, and authenticity of the transmitted prescription drug order consistent with federal or state laws and rules and regulations adopted pursuant to the same.
- E. An electronically transmitted prescription/order from a prescriber to a pharmacist shall be considered a highly confidential transaction and the said transmission shall not be compromised by interventions, control, change, altering or manipulation by any other person or parties in any manner whatsoever.
- F. Any pharmacist that transmits, receives or maintains any prescription or prescription refill either orally, in writing or electronically shall ensure the security, integrity and confidentiality of the prescription and any information contained therein.
- G. To maintain the confidentiality of patient and prescriber records, a computer system shall have security and system safeguards designed to prevent and detect unauthorized access, modification or manipulation of patient records. Once the drug has been dispensed, any alterations in prescription drug order data shall be documented to include the identification of the individual responsible for the alteration.
- H. Electronic transmission of prescription orders for controlled substances must comply with DEA Regulations.

Specifically, pharmacy technician Ashokkumar Patel (PT-220662), was receiving prescriptions via email and then entering them into the computer as if they were an e-prescribed prescription. The emailed prescriptions were being sent by another pharmacy and not the prescriber. As the pharmacist-in-charge, April Miller was responsible for complete supervision, management and compliance with all federal and state pharmacy laws and regulations pertaining to the practice of pharmacy in the entire prescription department.

Mississippi Pharmacy Practice Regulations Article VIII RESPONSIBILITY OF PHARMACIST/PHARMACIST CARE, paragraph 1, C. (2):

- 1. In the dispensing of drugs, the pharmacist shall have the following responsibilities:
  - C. In the dispensing of medications for ambulatory (or outpatients):
    - (2) The pharmacist shall be present and personally supervising the activities of the pharmacy technician at all times.

Specifically, pharmacy technician, Rinkuben Patel (PT-220770) was entering prescription information into the pharmacy computer (remote order entry) from her home with no supervision. Patel performed input of 33 % of all prescriptions processed on 12/17/ 20.

Mississippi Pharmacy Practice Regulations Article VIII RESPONSIBILITY OF PHARMACIST/PHARMACIST CARE, paragraph 1, C. (5):

- 1. In the dispensing of drugs, the pharmacist shall have the following responsibilities:
  - C. In the dispensing of medications for ambulatory (or outpatients):



- (5) A pharmacist shall not actively supervise more than three pharmacy technicians at one time.

Specifically, on December 17, 2020, Compliance Agent Brad Hammons observed April Miller, License to Practice Pharmacy, Certificate of Registration Number E-010200, supervising four (4) pharmacy technicians from 10:00 a.m. to 11:25 at D&B Discount Drugs, Permit #01593/1.1. Tracy Nichols (PT-08857), Brandi Neuhaus (PT-0159), Jigarkumar Patel (PT-223361) and Ashokkumar Patel (PT-220662) all performed pharmacy technician duties for the pharmacy while Miller was the only pharmacist present.

Compliance Agent Brad Hammons also observed Chad M. Burch, License to Practice Pharmacy, Certificate of Registration Number E-16079, supervising four (4) pharmacy technicians from 11:30 a.m. to 12:00 noon at D&B Discount Drugs, Permit #01593/1.1. Tracy Nichols (PT-08857), Brandi Neuhaus (PT-0159), Jigarkumar Patel (PT-223285) and Ashokkumar Patel (PT-220662) all performed pharmacy technician duties for the pharmacy while Burch was the only pharmacist present.

#### FINDINGS OF FACT

The Mississippi Board of Pharmacy, after being presented clear and convincing evidence, makes the following findings of fact:

- (1) The "Notice of Hearing and Complaint" along with a sworn affidavit detailing those charges was served pursuant to Section 73-21-99, Mississippi Code of 1972, Annotated.
- (2) The Respondent has been afforded all due process required by law.
- (3) The Respondent was issued a Permit to Operate a Pharmacy Number 01593/1.1, and as such was subject to jurisdiction of the Board pursuant to Section 73-21-97 (1)(f), Mississippi Code of 1972, Annotated.
- (4) The Respondent committed all four (4) violations as charged.






#### FINAL ORDER OF THE BOARD

The Mississippi Board of Pharmacy has jurisdiction of the subject matter and person of Raymond Drug Store, Permit to Operate as a Pharmacy, Permit Number 00820/1.1, pursuant to Section 73-21-97 (1)(f), Mississippi Code of 1972, Annotated.

#### STATEMENT OF CHARGES

Raymond Drug Store, Permit to Operate as a Pharmacy, Permit Number 00820/1.1, is alleged to have committed the following violations:

#### **Mississippi Pharmacy Practice Regulations Article IX ACTION AGAINST PERMITS, Paragraph 1, B:**

1. The Board of Pharmacy may refuse to issue or renew, or may suspend, summarily suspend, place on probation, revoke, reprimand, or restrict the permit of any permitted facility and/or impose a monetary penalty upon one or more of the following grounds:
  - B. Any act by any person in the conduct of the activities of the facility which is a violation of the rules and regulations of the Board of Pharmacy.

#### **(Count 1)**

#### **Mississippi Pharmacy Practice Regulations Article VIII RESPONSIBILITY OF PHARMACIST/PHARMACIST CARE, Paragraph 3:**

3. Prospective Drug Use Review:

Before a prescription is dispensed, delivered, or distributed, a pharmacist shall review the patient record and each Prescription Drug Order presented for dispensing for purposes of promoting therapeutic appropriateness by screening:

  - A. Over-utilization or under-utilization;
  - B. Therapeutic duplication;
  - C. Drug-disease contraindications;
  - D. Drug-drug interactions;
  - E. Incorrect drug dosage or duration of drug treatment;
  - F. Drug-allergy interactions; and,



G. Clinical abuse/misuse.

Upon recognizing any of the above, the pharmacist shall take appropriate steps to avoid or resolve the problem which shall, if necessary, include consultation with the prescriber.

Specifically, an inspection on May 24, 2021 revealed that the computer system for Raymond Drug Store, Permit Number 00820/1.1 was not operational and had been nonfunctional since February 19, 2021. Drug use reviews have not been performed on prescriptions dispensed since February 19, 2021.

**(Count 2)**

**Mississippi Pharmacy Practice Regulations Article XIV LABELING REQUIREMENTS, Paragraph 1:**

1. Before a dispensed drug for an outpatient is released from the dispensing area, it shall bear a label containing the name and address of the pharmacy, a prescription number, the name of the prescriber, the name of the patient, directions for taking the medication, the date of the filling or refilling of the prescription, the initials or identifying code of the dispensing pharmacist, and any other information which is necessary or required.

Specifically, the labels on new prescriptions dispensed after February 19, 2021, did not contain the name and address of the dispensing pharmacy.

**(Count 3)**

**Mississippi Pharmacy Practice Regulations Article XIV LABELING REQUIREMENTS, Paragraph 2:**

2. The pharmacist who fills a prescription shall indicate his or her identity as the dispensing pharmacist on the label of the dispensed medication. Identification may be made by placing initials on the label of the dispensed medication. The label shall be affixed to the outside of the container of the dispensed medication by means of adhesive, tape, or any other means which will assure that the label remains attached to the container.

Specifically, new prescriptions dispensed after February 19, 2021, would be placed in a vial and a handwritten piece of paper replicating a prescription label would be handed to the patient, the handwritten label would not be affixed to the vial.

**(Count 4)**

**Mississippi Pharmacy Practice Regulations Article XII PRESCRIPTION/ORDER REQUIRED AND REFILL AUTHORIZATION/RECORDKEEPING, Paragraph 6:**

6. The pharmacist who fills or refills a prescription shall record the date of the dispensing and indicate his/her identity as the dispensing pharmacist on the prescription document or some other appropriate and uniformly maintained record. If this record is maintained on the original prescription document, the original dispensing and any refills must be recorded on the back of the prescription.



Specifically, Raymond Drug Store, Pharmacy Permit Number 00820/1.1 did not maintain an appropriate uniform record of all prescriptions dispensed and/refilled since February 2021. Some prescriptions did not have the date of the dispensing recorded. Original prescription records were maintained separately from refill records. Refills were recorded on a paper log using the date of refill, the patient's name and the original prescription number. There is no documentation indicating the number of the refill being dispensed.

**(Count 5)**

**Mississippi Pharmacy Practice Regulations Article XVII REQUIREMENTS OF CONTROLLED SUBSTANCES PRESCRIPTIONS:**

Before they may be dispensed by a pharmacist, all prescriptions for controlled substances shall be dated and signed on the day when issued and shall bear the name and address of the patient and the name, address and registration number of the prescriber. The prescription must bear an original signature of the prescriber, facsimile stamps are not acceptable. The signature requirement does not apply to Schedule III, IV, or V prescriptions which are transmitted orally or electronically by the prescriber or his authorized agent to the pharmacist. Electronically transmitted orders for controlled substances must comply with DEA regulations.

Specifically, many of the controlled substance prescriptions dispensed by Raymond Drug Store, Pharmacy Permit Number 00820/1.1, did not bear the address of the patient, the address and DEA number of the prescriber and the date the prescription was ordered and dispensed.

**(Count 6)**

**Mississippi Pharmacy Practice Regulations Article XLIII PRESCRIPTION MONITORING PROGRAM, Paragraph 1, f:**

The Mississippi Board of Pharmacy shall operate a Prescription Monitoring Program (PMP) as provided for in Mississippi Code Annotated Section 73-21-127.

1. In addition to the provisions of Mississippi Code Annotated Section 73-21-127, the following reporting provisions shall apply:
  - a. Direct administration of a controlled substance to the body of an ultimate user (such as in an inpatient setting) is exempt from reporting.
  - b. Any quantity of drug dispensed that is limited to an amount adequate to treat the ultimate user for 48 hours or less is exempt from reporting.
  - c. Dispensing by a veterinarian is exempt, however prescriptions written by a veterinarian and filled by a pharmacy are required to be reported by the pharmacy.
  - d. Controlled substance prescriptions dispensed for patients in nursing homes, ICFMRs, and Assisted Living facilities ARE required to be reported.
  - e. Mail Order pharmacies (in Mississippi, or shipping into Mississippi) shall report to the Mississippi Prescription Monitoring Program.
  - f. Pharmacies shall report controlled substance dispensing information every twenty-four (24) hours or the next business day.



Specifically, Raymond Drug Store, Pharmacy Permit Number 00820/1.1 has not reported controlled substance dispensing information every twenty-four (24) hours or the next business day since late February 2021.

(Count 7)

**Mississippi Pharmacy Practice Regulations Article XLIII PRESCRIPTION MONITORING PROGRAM, Paragraphs 3-5:**

The Mississippi Board of Pharmacy shall operate a Prescription Monitoring Program (PMP) as provided for in Mississippi Code Annotated Section 73-21-127.

3. It is the intent of the Board that pharmacists utilize the PMP on a regular basis based on their professional judgment.
4. Prior to dispensing a prescription for a Schedule II opiate, a pharmacist shall review the prescription monitoring program based on any of the following circumstances:
  - a. The patient is a new customer to that pharmacy; or
  - b. The patient has not had an opioid prescription filled at that pharmacy within six (6) months;
5. The prescription monitoring program shall be reviewed at least once every six (6) months for any patient receiving controlled substances.

Specifically, Raymond Bauer, Pharmacist License Number R-07676, has never checked the Prescription Monitoring Program for patients receiving controlled substances.

- (1) The "Notice of Hearing and Complaint" along with a sworn affidavit detailing those charges was hand delivered at least thirty (30) days prior to the hearing.

- (3) The Respondent was issued a Permit to Operate a Pharmacy Number 00820/1.1, and as such was subject to jurisdiction of the Board pursuant to Section 73-21-97 (1)(f), Mississippi Code of 1972, Annotated.
- (4) The Respondent did not appear for the hearing and the hearing was held in absentia.
- (5) The Respondent committed the violations as charged.
