Specifically, Stephanie L. George, Pharmacy Technician Registration Number PT-08382 admitted to the theft of controlled substances from the pharmacy where she worked. George voluntarily surrendered her technician registration on February 10, 2022.

FINDINGS OF FACT

The Mississippi Board of Pharmacy, after being presented clear and convincing evidence, makes the following findings of fact:

- (1) The "Notice of Hearing and Complaint" along with a sworn affidavit detailing those charges was served pursuant to Section 73-21-99, Mississippi Code of 1972, Annotated.
- (2) The Respondent has been afforded all due process required by law.
- (3) The Respondent was issued a pharmacy technician registration by the Board, Pharmacy Technician Registration Number PT-08382, and as such was subject to jurisdiction of the Board pursuant to Section 73-21-97 (1)(f), Mississippi Code of 1972, Annotated.

The Mississippi Board of Pharmacy has jurisdiction of the subject matter and person of James R. Bullock, License to Practice Pharmacy, Certificate of Registration Number E-06064, pursuant to Section 73-21-97 (1)(f), Mississippi Code of 1972, Annotated.

STATEMENT OF CHARGES

James R. Bullock, License to Practice Pharmacy, Certificate of Registration Number E-06064, is alleged to have committed the following violation:

Mississippi Board of Pharmacy Administrative Rules, Rule 2.1 F:

Violation of any of the provisions of the Mississippi Pharmacy Practice Act or rules or regulations adopted pursuant to such Act; or violation of pharmacy or drug laws of any other state or the federal government or the rules/regulations pertaining thereto.

Count 1:

Mississippi Pharmacy Practice Regulations Article VII, RESPONSIBILITY OF PHARMACIST-IN-CHARGE (PIC), Paragraph 4:

4. If a permitted facility is permanently closed or has a change of ownership, the pharmacist-in charge for that facility shall give notice to the Board of the effective date of closure or change in ownership and include the storage location of the business's records and appropriate contact information. If a permitted facility has a change in name or location, application for a new permit must be made to the Board at least fifteen (15) days prior to the change in name or location. Once issued, a permit cannot be amended, transferred or assigned to another person.

Specifically, Sav-Rite Disc Drugs, Pharmacy Permit # 01134/1.1, closed sometime between September 14, 2021 and November 10, 2021 and did not provide the appropriate notice to the Board of the closure. James R. Bullock, License to Practice Pharmacy, Certificate of Registration Number E-06064, was the pharmacist-in-charge and was responsible for providing notice to the Board of the store closing.

Count 2:

Mississippi Pharmacy Practice Regulations Article XXV, INVENTORY REQUIREMENTS FOR CONTROLLED SUBSTANCES, Paragraph 2:

2. When a facility has a change in ownership or a change in pharmacist-in-charge, or is permanently closed, a complete inventory shall be made of all controlled substances at the time of the change. A copy of this inventory shall be kept with other records of controlled substances in the facility and a copy shall be sent to the office of the Board of Pharmacy. When a facility is permanently closed, the pharmacist-in-charge shall notify the Board in writing within fourteen (14) days by what means and as to whom controlled substances were transferred or disposed of.

Specifically, Sav-Rite Disc Drugs, Pharmacy Permit # 01134/1.1, closed sometime between September 14, 2021 and November 10, 2021. James R. Bullock, License to Practice Pharmacy, Certificate of Registration Number E-06064, as the pharmacist-in-charge did not notify the Board in writing within fourteen (14) days by what means and as to whom controlled substances were transferred or disposed of as required by the regulation.

Count 3:

Mississippi Board of Pharmacy Administrative Rules, Rule 2.1, M:

Rule 2.1: Grounds for Disciplinary Actions.

The Board may refuse to issue or renew, or may suspend, reprimand, revoke or restrict the license, registration or permit or any person upon one or more of the following grounds:

M. The unlawful or unauthorized possession or use of a controlled substance.

Specifically, after the closing of Sav-Rite Disc Drugs, Pharmacy Permit # 01134/1.1, James R. Bullock, License to Practice Pharmacy, Certificate of Registration Number E-06064 moved the controlled substances from the pharmacy to his personal residence. After the pharmacy closed, Bullock had no authority to possess controlled substances, either at the drug store location or at his personal residence where he transferred and stored the controlled substances.

Count 4:

Mississippi Board of Pharmacy Administrative Rules, Rule 2.1, R:

Rule 2.1: Grounds for Disciplinary Actions.

The Board may refuse to issue or renew, or may suspend, reprimand, revoke or restrict the license, registration or permit or any person upon one or more of the following grounds:

R. Failure to obtain the license, registration or permit required by this Mississippi Pharmacy Practice Act.

Specifically, the pharmacy permit of Sav-Rite Disc Drugs, Pharmacy Permit # 01134/1.1 expired December 31, 2021. At some point, James R. Bullock, License to Practice Pharmacy, Certificate of Registration Number E-06064 moved the controlled substances from the pharmacy to his personal residence. Bullock failed to maintain a permit, either at the pharmacy location or at his personal residence where he stored the controlled substances.

FINDINGS OF FACT

The Mississippi Board of Pharmacy, after being presented clear and convincing evidence, makes the following findings of fact:

- (1) The "Notice of Hearing and Complaint" along with a sworn affidavit detailing those charges was served pursuant to Section 73-21-99, Mississippi Code of 1972, Annotated.
- (2) The Respondent has been afforded all due process required by law.
- (3) The Respondent did not appear for the hearing and the hearing was held in absentia.
- (4) The Respondent was issued a pharmacist license by the Board, Pharmacist License, Certificate of Registration Number E-06064, and as such was subject to jurisdiction of the Board pursuant to Section 73-21-97 (1)(f), Mississippi Code of 1972, Annotated.
- (5) The Respondent committed the violations as charged.
- (6) The Respondent has retired his Pharmacist License, Certificate of Registration Number E-06064.

FINAL ORDER OF THE BOARD

This ORDER OF THE BOARD is effective immediately. A certified copy of this ORDER shall be served on the Respondent and a copy maintained in the office of the Board.

- Respondent's license shall remain retired and shall not be reinstated unless the Respondent personally appears before the Board to request reinstatement.

Ray E. Dukes, License to Practice Pharmacy, Certificate of Registration Number E-05791, is alleged to have committed the following violation:

Mississippi Board of Pharmacy Administrative Rules, Rule 2.1 F:

Violation of any of the provisions of the Mississippi Pharmacy Practice Act or rules or regulations adopted pursuant to such Act; or violation of pharmacy or drug laws of any other state or the federal government or the rules/regulations pertaining thereto.

Mississippi Pharmacy Practice Regulations Article VIII, RESPONSIBILITY OF PHARMACIST/PHARMACIST CARE, Paragraph 1. C, (2):

C. In the dispensing of medications for ambulatory (or outpatients):

- (2) The pharmacist shall be present and personally supervising the activities of the pharmacy technician at all times;

Specifically, Ray E. Dukes, License to Practice Pharmacy, Certificate of Registration Number E-05791, would leave Fayette Discount Drugs, Permit #06117/1.1 to go dispense medications at Jefferson County Hospital. This would leave the pharmacy technicians working at Fayette Discount Drugs unsupervised for about thirty to forty-five minutes each day he worked.

FINDINGS OF FACT

The Mississippi Board of Pharmacy, after being presented clear and convincing evidence, makes the following findings of fact:

- (1) The "Notice of Hearing and Complaint" along with a sworn affidavit detailing those charges was served pursuant to Section 73-21-99, Mississippi Code of 1972, Annotated.

- (2) The Respondent has been afforded all due process required by law.
- (3) The Respondent was issued a pharmacist license by the Board, Pharmacist License, Certificate of Registration Number E-05791, and as such was subject to jurisdiction of the Board pursuant to Section 73-21-97 (1)(f), Mississippi Code of 1972, Annotated.
- (4) The Respondent admitted to the violation as charged.













Count 2:

Mississippi Pharmacy Practice Regulations Article XXIV, SECURITY OF CONTROLLED SUBSTANCES:

In all places where controlled substances are maintained, they shall be maintained in a manner to deter loss by theft or burglary. When a person who has a controlled substances registration with the Board of Pharmacy has a loss of controlled substances, the Board may issue an order to that person to appear before the Board to present a plan to the Board designed to prevent further loss of controlled substances or he/she may be ordered by the Board to implement any other reasonable measures to improve security on controlled substances deemed necessary by the Board or prevent further loss of controlled substances.

Specifically, an investigation by the Compliance Division of the Mississippi Board of Pharmacy revealed that several employees of Fayette Discount Drugs, Permit #06117/1.1, were stealing large amounts of controlled substances, to include: Alprazolam, Clonazepam, Hydrocodone and others. As the pharmacist-in-charge, Jason M. Cannon, License to Practice Pharmacy, Certificate of Registration Number E-09185, was responsible for ensuring the security of the controlled substances.

 - A. That in pharmacies with a manual record keeping system the transferor pharmacist invalidates the prescription on file as of the date the copy is given by writing "Void" on its

- face; and records on the back of the invalidated prescription order that a copy has been issued, to whom, the date of issuance of such copy and the initials of the pharmacist issuing the transferred prescription.
- B. That in pharmacies with a computerized record keeping system the transferor pharmacist records in the system a cancellation of the prescription. This cancellation shall record that a copy of the prescription has been issued, to whom it was issued, the date of issuance of such copy and the initials of the pharmacist issuing the copy. This required information must be immediately retrievable (via CRT display or hard copy printout).
- C. The transferee pharmacist, upon receiving such prescription directly from another pharmacist, records the following and enters into the data processing system:
- (1) **The name and address of the pharmacy from which the prescription was transferred and the original prescription number used by that pharmacy;**
 - (2) **The name of the transferor pharmacist;**
 - (3) **All information constituting a prescription order, including the following:**
 - (a) **Patient's name.**
 - (b) **Date of issuance of original prescription and date of original dispensing.**
 - (c) **Original number of refills authorized on original prescription;**
 - (d) **Number of valid refills remaining.**
- D. The receiving pharmacist informs the patient that the original prescription has been canceled at the pharmacy from which it was obtained.
2. Computerized systems must satisfy all requirements of paragraph 1. of this ARTICLE.
3. Presentation of a written prescription copy or label from dispensed medication shall be for information purposes only and has no legal status as a valid prescription order. The recipient pharmacist of such copy or prescription label shall contact the prescribing practitioner for authorization to dispense the prescription, which is the same as obtaining an original prescription order or transfer the prescription in accordance with the provisions of paragraph 1. of this ARTICLE.

Before making a final decision, the Board entertained a motion for Settlement from the Respondents. The Board continued the matter until the next Board meeting to allow time for settlement negotiations.
