EXECUTIVE DIRECTOR REPORT

Susan McCoy, Executive Director, reported to the Board concerning day to day activities of the agency.

REGULATION WORKING GROUP

Todd Dear, Associate Director, provided an update on the activities of the regulation work group, including the holding of a public hearing on September 14, 2022, for the proposed regulation addressing shared services and amendments to the Definitions section and Article XXXII of the Regulations.

Upon a motion by Board member Guy Phillips and a 2nd by Craig Sartin, the Board voted unanimously to the changes proposed to Definitions sections and Article XXXII Pharmaceutical Facility Permits of the Regulations.

OLD BUSINESS

The Board did not discuss any old business.

NEW BUSINESS

The Board heard a presentation from Samuel Myers, the lead pharmacist at Baptist Memorial Hospital – Calhoun County. The presentation centered on Outpatient Retail Pharmacy Services at Small Community Hospitals within their existing institutional permit.

The Board also heard a presentation from Michelle Nguyen from Fresenius Kidney Care Pharmacy addressing the practice of dispensing maintenance medications to a dialysis center for patients to pick up when they present for dialysis treatment.

Upon a motion by Board member Ryan Harper and a 2nd by Board member Craig Sartin, the Board voted unanimously to go into executive session to discuss pursuant to Section 25-41-7(4)(a) and (b) for the purposes of discussing pending litigation, including an appeal of a Board order, and to discuss a personnel matter relating to job performance of a member of agency staff. On a motion by Board member Ryan Harper and a 2nd by Board member Jillian Foster, the Board voted unanimously to rise from executive session and enter open session. It was reported that no action was taken during executive session.

Upon a motion by Board member Ryan Harper and a 2nd by Tony Waits, the Board voted unanimously to increase the salary of the executive director to the maximum increase approved by the State Personnel Board, but not to exceed a 6% increase of the current salary, with salary increase to be effective January 1, 2023.

A motion to accept the settlement regarding Aetna Health Management, LLC was made by Ryan Harper and a 2nd by Jillian Foster. Motion was tabled until settlement negotiations are finally concluded.

JURISDICTION

The Mississippi Board of Pharmacy has jurisdiction of the subject matter and person of CVS Pharmacy #10400, Pharmacy Permit Number 13885/1.2; CVS Pharmacy #11114, Pharmacy Permit Number 05284/7.1; and CVS Specialty, Pharmacy Permit Number 04877/7.1, pursuant to Section 73-21-97(1)(f), Mississippi Code of 1972, Annotated.

STATEMENT OF CHARGES

CVS Pharmacy #10400, Pharmacy Permit Number 13885/1.2; CVS Pharmacy #11114, Pharmacy Permit Number 05284/7.1; and CVS Specialty, Pharmacy Permit Number 04877/7.1 are all alleged to have committed a violation of the following:

Mississippi Pharmacy Practice Regulations, Article XV Issuance and Receipt of Prescription Copies, Paragraph 1., C:

1. Prescriptions for drugs which are controlled substances as defined by the Mississippi Uniform Controlled Substances Law shall not be transferred. Prescriptions for noncontrolled drugs may be transferred orally by telephone or electronically (to include facsimile) by pharmacists between pharmacies for the purpose of refill dispensing provided:
 - A. That in pharmacies with a manual record keeping system the transferor pharmacist invalidates the prescription on file as of the date the copy is given by writing "Void" on its face; and records on the back of the invalidated prescription order that a copy has been

- issued, to whom, the date of issuance of such copy and the initials of the pharmacist issuing the transferred prescription.
- B. That in pharmacies with a computerized record keeping system the transferor pharmacist records in the system a cancellation of the prescription. This cancellation shall record that a copy of the prescription has been issued, to whom it was issued, the date of issuance of such copy and the initials of the pharmacist issuing the copy. This required information must be immediately retrievable (via CRT display or hard copy printout).
 - C. The transferee pharmacist, upon receiving such prescription directly from another pharmacist, records the following and enters into the data processing system:
 - (1) The name and address of the pharmacy from which the prescription was transferred and the original prescription number used by that pharmacy;
 - (2) The name of the transferor pharmacist;
 - (3) All information constituting a prescription order, including the following:
 - (a) Patient's name.
 - (b) Date of issuance of original prescription and date of original dispensing.
 - (c) Original number of refills authorized on original prescription;
 - (d) Number of valid refills remaining.
 - D. The receiving pharmacist informs the patient that the original prescription has been canceled at the pharmacy from which it was obtained.
- 2. Computerized systems must satisfy all requirements of paragraph 1. of this ARTICLE.
 - 3. Presentation of a written prescription copy or label from dispensed medication shall be for information purposes only and has no legal status as a valid prescription order. The recipient pharmacist of such copy or prescription label shall contact the prescribing practitioner for authorization to dispense the prescription, which is the same as obtaining an original prescription order or transfer the prescription in accordance with the provisions of paragraph 1. of this ARTICLE.

PROCEEDINGS

The Mississippi Board of Pharmacy heard testimony and received evidence during a hearing on this matter on July 21, 2022. Before making a final decision, the Board entertained a motion for Settlement from the Respondents and continued the matter until the September Board meeting to allow time for settlement negotiations. The Board further continued the matter until the November Board meeting to allow additional time for settlement negotiations. The parties were unable to reach a settlement and the Board deliberated on the matter.

FINDINGS OF FACT

The Mississippi Board of Pharmacy, after being presented clear and convincing evidence, makes the following findings of fact:

- (1) The "Notice of Hearing and Complaint" along with a sworn affidavit detailing those charges was served pursuant to Section 73-21-99, Mississippi Code of 1972, Annotated.
- (2) The Respondent has been afforded all due process required by law.
- (3) The Respondent was represented by counsel during all proceedings in this matter.
- (4) The evidence presented at the hearing did not support a finding against the Respondents.

FINAL ORDER OF THE BOARD

This ORDER OF THE BOARD is effective immediately. A certified copy of this ORDER shall be served on the Respondent and a copy maintained in the office of the Board.

All charges filed against the Respondents in this matter are dismissed.



STATEMENT OF CHARGES

Mitzie A. Ward, Pharmacy Technician Registration Number PT-213849, is alleged to have committed the following violation:

Mississippi Board of Pharmacy Administrative Rules, Rule 2.1 J:

Addiction to or dependence on alcohol, controlled substances or other habit-forming legend drugs or the unauthorized use, possession or theft of controlled substances or other habit-forming legend drugs.

Specifically, Mitzie A. Ward, Pharmacy Technician Registration Number PT-213849, surrendered her pharmacy technician registration due to testing positive on a drug screen. Ward voluntarily surrendered her technician registration on August 28, 2022.

FINDINGS OF FACT

The Mississippi Board of Pharmacy, after being presented clear and convincing evidence, makes the following findings of fact:

- (1) The "Notice of Hearing and Complaint" along with a sworn affidavit detailing those charges was served pursuant to Section 73-21-99, Mississippi Code of 1972, Annotated.
- (2) The Respondent has been afforded all due process required by law.

Theft or embezzlement of prescription drugs, controlled substances, medical devices or funds from a permitted facility.

Specifically, Kiara A. Darby, Pharmacy Technician Registration Number PT-224276 admitted to the theft of funds from the pharmacy where she worked. Darby voluntarily surrendered her technician registration on June 3, 2022.

- (1) The "Notice of Hearing and Complaint" along with a sworn affidavit detailing those charges was served pursuant to Section 73-21-99, Mississippi Code of 1972, Annotated.

- (6) The Respondent voluntarily surrendered her pharmacy technician registration.



- Pursuant to Section 73-21-103(1)(d)(iii), Mississippi Code of 1972, Annotated, a monetary penalty of Five Hundred Sixty-Five Dollars (\$565.00) is imposed on the Respondent for the cost of investigation and conduct of a proceeding.
- The total monetary penalty and cost of investigation in the amount of Eight Thousand Five Hundred Sixty-Five Dollars (\$8,565.00) shall be paid by the Respondent within thirty (30) days of this Order



The Mississippi Board of Pharmacy has jurisdiction of the subject matter and person of Clint E. Bane, License to Practice Pharmacy, Certificate of Registration Number E-07204, pursuant to Section 73-21-97(1)(f), Mississippi Code of 1972, Annotated.

STATEMENT OF CHARGES

Clint E. Bane, License to Practice Pharmacy, Certificate of Registration Number E-07204, is alleged to have committed the following violations:

Mississippi Board of Pharmacy Administrative Rules, Rule 2.1 F:

Violation of any of the provisions of the Mississippi Pharmacy Practice Act or rules or regulations adopted pursuant to such Act; or violation of pharmacy or drug laws of any other state or the federal government or the rules/regulations pertaining thereto.

Count 1:

Mississippi Pharmacy Practice Regulations Article XII Prescription/Order Required and Refill Authorization/Recordkeeping, Paragraph 1:

Prescription drugs shall be dispensed only pursuant to a valid prescription or a valid order.

Specifically, Clint E. Bane, License to Practice Pharmacy, Certificate of Registration Number E-07204, admitted to dispensing non-controlled drugs without a prescription and trying to get a prescription after-the-fact.

Count 2:

Mississippi Pharmacy Practice Regulations Article XII Prescription/Order Required and Refill Authorization/Recordkeeping, Paragraph 3:

Pharmacists must maintain complete and accurate records of all prescription drugs received, disposed of, or dispensed at a permitted facility.

Specifically, an audit done by the Compliance Division of the Mississippi Board of Pharmacy (Board) revealed discrepancies in the inventory of both controlled and legend drugs at the facility. Some drugs were at the facility without the proper acquisition records and there were drugs missing from the facility without the proper disposition or dispensing records.

Count 3:

Mississippi Pharmacy Practice Regulations Article VII, Responsibility of Pharmacist-in-Charge (PIC), Paragraph 5. C:

The pharmacist-in-charge shall be responsible for adequate security being always maintained on drugs in all areas of the permitted facility and is responsible for reporting any loss or suspected loss of controlled substances or legend drugs directly to the Board immediately (this does not relieve any pharmacist who discovers a loss from the requirement of reporting the loss directly to the Board).

Specifically, an audit of the facility's drugs revealed that the facility was missing drugs, both controlled substances and legend drugs. As the pharmacist-in-charge, Clint E. Bane, License to Practice Pharmacy, Certificate of Registration Number E-07204, was responsible for the security of those drugs and for reporting any losses or suspected losses to the Board. Bane never reported any losses to the Board.

FINDINGS OF FACT

The Mississippi Board of Pharmacy, after being presented clear and convincing evidence, makes the following findings of fact:

- (1) The "Notice of Hearing and Complaint" along with a sworn affidavit detailing those charges was served pursuant to Section 73-21-99, Mississippi Code of 1972, Annotated.
- (2) The Respondent has been afforded all due process required by law.
- (3) The Respondent was issued a License to Practice Pharmacy, Certificate of Registration Number E-07204, and as such was subject to jurisdiction of the Board pursuant to Section 73-21-97 (1)(f), Mississippi Code of 1972, Annotated.
- (4) The Respondent violated the charges of Count 1 and dispensed at least three hundred and fifty (350) prescription drugs without a valid prescription or order
- (5) The Respondent violated the charges of Count 2.
- (6) There was insufficient evidence for the Board to sustain the charge of Count 3.

FINAL ORDER OF THE BOARD

This ORDER OF THE BOARD is effective immediately. A certified copy of this ORDER shall be served on the Respondent and a copy maintained in the office of the Board.





- The total monetary penalty Eleven Thousand Twenty-Three Dollars (\$11,023.00) shall be due and payable within thirty (30) days of this Order.



STATEMENT OF CHARGES

Amanda E. Russell, License to Practice Pharmacy, Certificate of Registration Number E-09597, is alleged to have committed the following violation:

Mississippi Board of Pharmacy Administrative Rules, Rule 2.1 H:

Failure to comply with lawful orders of the Board.

Specifically, on July 16, 2020, the Board issued an Order renewing the License to Practice Pharmacy, Certificate of Registration Number E-09597, for Amanda Russell. The Board's Order contained the following conditions for Russell (Petitioner):

- The Petitioner's intern registration and pharmacist license shall be placed on probation for ten (10) years beginning July 16, 2020 and expiring July 15, 2030;
- The Petitioner shall enter into a ten (10) year Board approved contract with the Mississippi Association of Recovering Pharmacists (MARP) and comply with all terms of that contract. A copy of the contract shall be provided to the Mississippi Board of Pharmacy;
- The Petitioner shall be subject to the following conditions and restrictions indefinitely:
 - Petitioner shall abstain from the use of alcohol or the unauthorized use of controlled substances or other habit-forming legend drugs;
 - Petitioner shall not take any mood-altering drug which has not been prescribed for her;
 - Petitioner shall immediately inform the Board in writing (by email or fax) of all medications prescribed for her, stating the name of the drug, the number and strength of the doses prescribed, the dosage regimen and the name and registration number of the prescriber;
 - The Petitioner shall submit a urine specimen, serum specimen or hair sample when requested by the Board or any agent of the Board of Pharmacy;

- Petitioner shall keep the Board informed at all times as to the place of her employment as a Pharmacist and any change in residential address;
- Petitioner shall submit a written quarterly report (on a form prescribed by the Board) to the Board, due the first week of January, April, July and October, detailing her personal and professional well-being.

Russell submitted to a urine screen on July 6, 2022 and the results of the screen indicated positive for oxycodone. Russell admitted to taking a few Percocet from the cabinet of a friend's house. Russell did not have a prescription for this medication. This is a violation of the July 16, 2020 Board Order which prohibited Russell from taking any mood-altering drug which was not prescribed for her. Amanda E. Russell surrendered her License to Practice Pharmacy, Certificate of Registration Number E-09597, on July 25, 2022.

PROCEEDINGS

Respondent did not receive notice of the hearing at least thirty (30) prior to the hearing as required by statute but waived her right to be noticed of the hearing at least thirty (30) days prior to the hearing and requested to proceed with the hearing. The Mississippi Board of Pharmacy heard testimony and received evidence during a hearing on this matter.
