Susan McCoy, Executive Director, reported to the Board that staff had been working diligently under special circumstances due to the COVIS-19 pandemic with several staff members working from home and coming to the office on an "as needed" basis. Protective measures have been taken around the office to ensure that the working conditions are safe for employees.

 The Board voted to table the consideration of this regulation amendment until the next Board meeting. Board member Todd Barrett dissented in the vote.
- Article VII Responsibility of the Pharmacist-in-Charge (PIC) (see attached)
 Without objection, the Board voted to table the consideration of this regulation amendment until the next Board meeting and directed the staff to make changes to the proposed regulation amendment prior to the next meeting.
- Article XLVIII Telepharmacy (see attached)
 Without objection, the Board voted to table the consideration of this regulation amendment until the next Board meeting.
- Article XX Partial Filling of Schedule II Prescriptions (see attached)
 Without objection, the Board approved its intent to adopt this regulation amendment and directed the staff to proceed with adoption pursuant to the Administrative Procedures Act.

Following a discussion, the Board considered a motion to list Gabapentin as a drug of concern to be reported to the Prescription monitoring Program. Board members Todd Barrett, Ryan Harper and Clayton Farmer voted for the motion and Board members Ronnie Bagwell, Guy Phillips, Jillian Foster and Larry Calvert voted against the motion. The motion failed.

No action was taken following a discussion of whether to remove the probation status listed on the website for pharmacists who are on probation.

Following a discussion, the Board voted unanimously to waive the requirement that two (2) hours of continuing education must be "live CE" for the 2020 licensure period due to the COVID-19 pandemic. The requirement to obtain fifteen (15) total hours is still in effect but there is no live CE requirement for 2020.

STATEMENT OF CHARGES

Heather L. Welch, Pharmacy Technician Registration Number PT-221604, is alleged to have committed the following violation:

Mississippi Board of Pharmacy Administrative Rules, Rule 2.1 O:

The theft or embezzlement of prescription drugs, controlled substances, medical devices, or funds from a permitted facility.

Specifically, Welch admitted to taking neurontin/gabapentin out of a stock bottle from Walgreens #10805, permit #07408/1.2 in Magee, MS. Welch surrendered her pharmacy technician registration on November 22, 2019.

FINDINGS OF FACT

The Mississippi Board of Pharmacy, after being presented clear and convincing evidence, makes the following findings of fact:

(1) That the "Notice of Hearing and Complaint" along with a sworn affidavit detailing those charges was served pursuant to Section 73-21-99, Mississippi Code of 1972, Annotated;

(2) That the Respondent has been afforded all due process required by law;

- That the Respondent was issued a pharmacy technician registration by the Board, Pharmacy Technician Registration Number PT-221604, and as such was subject to jurisdiction of the Board pursuant to Section 73-21-97 (1)(f), Mississippi Code of 1972, Annotated;
- (4) That the Respondent committed the violation as charged; and
- (5) That the Respondent voluntarily surrendered her pharmacy technician registration.

- Pursuant to Section 73-21-103(1)(d)(i), Mississippi Code of 1972, Annotated, Respondent shall pay a monetary penalty of One Thousand Dollars (\$1,000.00).
- Pursuant to Section 73-21-103(1)(d)(iii), Mississippi Code of 1972, Annotated, Respondent shall pay and the cost of investigation and conduct of a proceeding in the amount of Two Hundred Fifty Dollars (\$250.00).
- The total monetary penalty and cost of investigation in the amount of One Thousand Two Hundred Fifty Dollars (\$1,250.00) shall be paid by the Respondent prior to the reinstatement of her registration.

STATEMENT OF CHARGES

Danielle B. Burk, License to Practice Pharmacy, Certificate of Registration Number E-11973, is alleged to have committed the following violation:

Mississippi Code Annotated Section 73-21-127 (d), which provides:

(d) The program shall provide information regarding the potential inappropriate use of controlled substances and the specified noncontrolled substances to practitioners, pharmacists-in-charge and appropriate state agencies in order to prevent the inappropriate or illegal use of these controlled substances. The specific purposes of the program shall be to: be proactive in safeguarding public health and safety; support the legitimate use of controlled substances; facilitate and encourage the identification, intervention with and treatment of individuals addicted to controlled substances and specified noncontrolled drugs; identify and prevent drug diversion; provide assistance to those state and federal law enforcement and regulatory agencies investigating cases of drug diversion or other misuse; and inform the public and health care professionals of the use and abuse trends related to controlled substance and specified noncontrolled drugs.

Mississippi Code Annotated Section 73-21-127 (g) provides:

(g) A dispenser pharmacist or practitioner licensed to dispense controlled substances and specified noncontrolled substance drugs who knowingly fails to submit drug monitoring information or knowingly submits incorrect dispensing information shall be subject to actions against the pharmacist's or practitioner's license, registrations or permit and/or an administrative penalty as provided in Sections 73-21-97 and 73-21-103. Any misuse of the PMP is subject to penalties as provided in Sections 73-21-97 and 73-21-103.

Specifically, Burk accessed the PMP data for Kenny Goralczyk on October 26, 2017 without a legitimate purpose.

SETTLEMENT AGREEMENT

Pursuant to discussions between Board Counsel and the Respondent, an Agreement to Settle this matter is found to be in the best interest of all parties involved. It is hereby Agreed as follows:

FINDINGS OF FACT

The Mississippi Board of Pharmacy, after being presented clear and convincing evidence, makes the following findings of fact:

- (1) That the Respondent was properly notified of the charges by a duly processed "Notice of Hearing and Complaint" along with a sworn affidavit detailing those charges as provided for in Section 73-21-99, Mississippi Code of 1972, Annotated, and the Respondent has been afforded all due process required by law;
- (2) That the Respondent was issued a license to practice pharmacy by the Board, Certificate of Registration Number E-11973, and as such was subject to jurisdiction of the Board pursuant to Section 73-21-97 (l)(f), Mississippi Code of 1972, Annotated;
- (3) That the Respondent does not contest the violation as charged; and,

I hereby agree to the findings and terms of this Agreed Order:

(4) That the Respondent agrees to the disciplinary action stated below as imposed by the Board.

FINAL ORDER OF THE BOARD

This ORDER OF THE BOARD is effective immediately. A certified copy of this ORDER shall be served on the Respondent and a copy maintained in the office of the Board.

- Pursuant to Section 73-21-103 (l)(d)(vi), Respondent shall pay a monetary penalty in the amount of One Thousand Dollars (\$1,000.00);
- Pursuant to Section 73-21-103 (l)(d)(iii), Respondent shall pay the cost of investigation and conduct of a proceeding in the amount of Five Hundred Fifty Dollars (\$550.00).
- The total monetary settlement and cost of investigation shall be One Thousand Five Hundred Fifty Dollars (\$1,550.00). The monetary settlement and cost of investigation shall be paid within thirty (30) days of receipt of this Order.

Mississippi Board of Pharmacy Administrative Rules, Rule 2.1, F:

Violation of any of the provisions of the Mississippi Pharmacy Practice Act or rules or regulations adopted pursuant to such Act; or violation of pharmacy or drug laws of any other state or the federal government or the rules/regulations pertaining thereto;

Mississippi Pharmacy Practice Regulations ARTICLE XXXIV, PHARMCY EXTERN/INTERN REGISTRATION, Paragraph 3, A:

The Board may refuse to issue or renew or may suspend, revoke or restrict the registration of any extern/intern upon one or more of the following grounds:

 A. Unprofessional conduct as defined in ARTICLE V, Paragraph 1, G., Pharmacy Practice Regulations of the Mississippi Board of Pharmacy;

Mississippi Pharmacy Practice Regulations ARTICLE V, Paragraph 1, G provides:

- G. Unprofessional conduct. Unprofessional conduct shall include, but is not limited to:
 - (1) Condoning or assisting in the dispensing, promotion, or distribution of drugs:
 - (a) Which do not meet the standards required by law;
 - (b) Which the pharmacist knows, or should know, are not obtained for legitimate medical need.

Specifically, Sierra R. Mohair, Intern/Extern Certificate of Registration Number IE-8534, attempted to administer a vaccine to a patient by using a syringe that had been discarded in a Sharps container.

SETTLEMENT AGREEMENT

Pursuant to discussions between Board Counsel and the Respondent, an Agreement to Settle this matter is found to be in the best interest of all parties involved. It is hereby Agreed as follows:
