CONCLUSION OF CONSENT AGENDA

EXECUTIVE DIRECTOR REPORT

Susan McCoy, Executive Director, reported to the Board concerning day to day activities of the agency. The new licensing system will be operational soon and additional components involving compliance and legal will be added after the initial launch.

GENERAL BUSINESS

Due to federal de-scheduling of Epidiolex and the passage of the Hemp Act by the state legislature, the Board discussed the legalities of whether Epidiolex remains a schedule drug under Mississippi law. No action was taken on this matter.

Tamika Russell from MAC Pharmaceuticals requested the Board allow her to keep the facility permit open even though the facility has closed its door to business. The reason for the request is that the reverse distributor has requested such action in order to provide a refund for returned drugs. Without objection, the Board voted to table the matter and requested Ms. Russell to gather information from the wholesaler concerning the need to keep a permit open for the purpose of issuing a refund on returned drugs.

Mississippi Code Annotated Section 73-21-127(i) provides:

"Practitioner," as used in this section, shall include any person licensed, registered or otherwise permitted to distribute, dispense, prescribe or administer a controlled substance, as defined under Section 41-29-105 (y) and any person defined as a "practitioner" under Section 73-21-73 (ee).

Mississippi Code Annotated Section 73-21-73(ee) provides:

"Practitioner" means a physician, dentist, veterinarian, or other health care provider authorized by law to diagnose and prescribe drugs.

Mississippi Code Annotated Section 73-21-127(d) provides:

The program shall provide information regarding the potential inappropriate use of controlled substances and the specified noncontrolled substances to practitioners, pharmacists-in-charge and appropriate state agencies in order to prevent the inappropriate or illegal use of these controlled substances. The specific purposes of the program shall be to: be proactive in safeguarding public health and safety; support the legitimate use of controlled substances; facilitate and encourage the identification, intervention with and

treatment of individuals addicted to controlled substances and specified noncontrolled drugs; identify and prevent drug diversion; provide assistance to those state and federal law enforcement and regulatory agencies investigating cases of drug diversion or other misuse; and inform the public and health care professionals of the use and abuse trends related to controlled substance and specified noncontrolled drugs.

Mississippi Code Annotated Section 73-21-127(e)(i) provides:

Access to collected data shall be confidential and not subject to the provisions of the federal Freedom of Information Act or the Mississippi Open Records Act. **Upon request, the State Board of Pharmacy shall provide collected information to: pharmacists or practitioners who are properly registered with the State Board of Pharmacy and are authorized to prescribe or dispense controlled substances for the purpose of providing medical and pharmaceutical care for their patients;** local, state and federal law enforcement officials engaged in the administration, investigation or enforcement of the laws governing illicit drug use; regulatory and licensing boards in this state; Division of Medicaid regarding Medicaid and Medicare Program recipients; judicial authorities under grand jury subpoena; an individual who requests the individual's own prescription monitoring information; and prescription monitoring programs in other states through mutual agreement adhering to State Board of Pharmacy policies.

Specifically, Sonya Whatley accessed the Prescription Monitoring Program (PMP) profile on her husband's ex-wife and several members of the ex-wife's family without having a patient relationship to the individuals. Whatley admitted to inappropriately using the PMP in an attempt to gather information to use in a custody battle involving her stepson. Whatley attempted eighty-five (85) inappropriate information requests from the PMP on or about the second week of October 2019.

FINDINGS OF FACT

The Mississippi Board of Pharmacy, after being presented clear and convincing evidence, makes the following findings of fact:

- (1) That the Respondent was properly notified of the charges by a duly processed "Notice of Hearing and Complaint" along with a sworn affidavit detailing those charges as provided for in Section 73-21-99, Mississippi Code of 1972, Annotated, and the Respondent has been afforded all due process required by law;
- (2) That the Respondent was subject to jurisdiction of the Board pursuant to Section 73-21-127(g), Mississippi Code of 1972, Annotated;
- (3) That the Respondent misused the Prescription Monitoring Program eighty-five (85) times.









- (3) That for an indefinite period of time, that she submit a serum specimen when requested by the Board or any agent of the Board of Pharmacy, and
- (4) That for an indefinite period of time, that she submit a hair sample when requested by the Board or any agent of the Board of Pharmacy; and
- (5) That during the period of probation, that she must keep the Board informed at all times as to the time and place of her employment as a pharmacist; and further, that she submit a quarterly report in writing to the Board detailing personal and professional well-being; and
- (6) **That during the period of probation, that she shall not take any drug, which has not been prescribed for her. That, except in an emergency, before ingesting any drug which has been prescribed, she shall inform the Executive Director or a Compliance Agent orally, by phone or by other means. That she follow**

this by written notice to the Executive Director of the Board within twenty-four (24) hours, stating the name of the drug ingested, the number and strength of the doses prescribed, the dosage regimen and the name and registration number of the prescriber; and

- (7) That she shall be in compliance with all state and federal laws and regulations of the Board; and
- (8) Further, that Ms. Williams' Failure to Comply with the terms of this AGREEMENT or her Contract with the Mississippi Association of Recovering Pharmacists (MARP) will result in the immediate suspension of her Pharmacist License.
