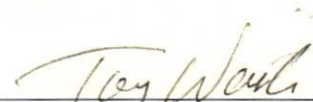

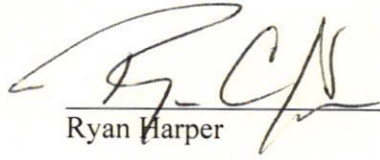
The Board adjourned at 11:51 a.m.

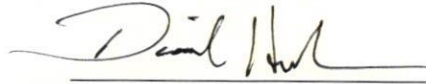
