The Mississippi Board of Pharmacy (MBP) conducted a Request for Proposal (RFP) solicitation to secure a vendor to provide Pharmacy Benefit Manager Audit Services. The RFP as amended, including terms, conditions, scope of services and other matters anticipated to be incorporated into the resulting contract, may be accessed at https://www.mbp.ms.gov/news/proposals-request-announcement-1.

With the goal of awarded a contract to include a one-year, one audit optional renewal, MBP evaluated the five proposals received to ensure they received a comprehensive, fair, and impartial evaluation. An internal evaluation committee utilized consensus scoring to evaluate the proposal using a two-step process including a Compliance Phase and an Analysis Phase. A detailed description of the evaluation process is provided in Section 9.2 of the RFP document. Evaluation factors and their respective weighting included Relevant firm experience (30%), Team experience and qualifications (25%), Project (RFP) understanding and approach (20%), Plan for project management (15%), and Other factors (such as ability to proceed immediately, length of time to be completed, etc). (10%). Also, the pricing of each proposal was considered in selecting the award.

As a result of the evaluation process described herein, the proposal is ranked by Offeror in the order of final score, highest to lowest, as follows:

MYERS & STAUFFER, LC HORNE, LLC PROVIDENCE HEALTH TECHNOLOGIES, LLC INS REGULATORY INSURANCE SERVICES, INC. LEWIS & ELLIS

The evaluation committee was comprised of the following individuals based on their knowledge and expertise related to the services being considered: Ronnie Bagwell, President of the MBP; Ryan Harper, Member of the MBP; David Hudson, Member of the MBP; Susan McCoy, Executive Director of the MBP; and Avery Lee, General Counsel for the MBP.

Based on the evaluation results, the Board voted to approve entering contract negotiations with MYERS & STAUFFER to provide pharmacy benefit manager audit services. Subject to successful negotiations a contract with an effective date of June 17, 2025, and term ending June 30, 2026, plus one optional one-year renewal contract for additional audits to be performed is expected to be executed with MYERS & STAUFFER, LC, at a contract value estimated to not exceed \$328,040.00 for the initial contract term.
