The Mississippi Board of Pharmacy (Board) held a special-called meeting at 8:30 a.m. on Friday December 5, 2025, at 6311 Ridgewood Road, Suite E-401, Jackson, MS 39211. The following members were present: Jillian Foster – President, Craig Sartin – Vice-President, Mike Gilbow – Secretary, Ryan Harper, Tony Waits, David Hudson and Patti Hawkins. Notice of the special-called meeting was posted on the door of the offices of the Board at 12:43 p.m. on December 3, 2025, and posted on the agency website. Notice is attached.

Meeting called to order by President of the Board, Jillian Foster, at 8:35 a.m.

Upon a motion by Board Member David Hudson, 2nd by Board Member Ryan Harper, the Board unanimously approved the minutes of the November 20, 2025 Board Meeting.

Upon a motion by Board Member David Hudson, 2nd by Board Member Mike Gilbow, the Board unanimously approved the University of Mississippi School of Pharmacy Prescription Monitoring Program publication.


Upon a motion by Board Member Craig Sartin, 2nd by Patti Hawkins, the Board unanimously approved amending previous Board Orders and Memorandum of Agreements of Licensees to include the new pharmacy professionals recovery services contractor, Professionals Health Network, LLC, with an effective date of December 15, 2025. All other terms of the previous Board Order remain unchanged.

Upon a motion by Board Member Craig Sartin, 2nd by Board Member Mike Gilbow, the Board unanimously voted for staff to communicate to legal counsel for Evernorth that in order to complete the application process, the Board requests a statement be uploaded in the licensing system that the pharmacy intends to comply with Mississippi law and Board regulations and will develop a process to fill Mississippi prescriptions in compliance with Mississippi law and Board regulations. If this is done prior to December 31, 2025, the Board will approve the renewal application and will also allow the pharmacy permit until April 1, 2026, to develop and implement a process to fill Mississippi prescriptions in a way that complies with all Mississippi laws and Board regulations.


General Counsel of the Board, Avery Lee, provided an update on pending litigation.





The Board met on December 5, 2025, to consider an amendment to the previous Orders of licensees and registrants of the performance of recovery services by the Mississippi Association of Recovering Pharmacists to be changed to Professionals Health Network, LLC., the new pharmacy professionals recovery services contractor. This Order amends the previous Orders of the listed licensees and registrants.

BEFORE THE MISSISSIPPI BOARD OF PHARMACY

JURISDICTION

The Mississippi Board of Pharmacy (Board) has jurisdiction of the subject matter pursuant to Section 73-21-83 and Section 73-21-103(2), Mississippi Code of 1972, Annotated.

PROCEEDINGS

In accordance with a competitive procurement process conducted by the Board pursuant to Mississippi law, Professionals Health Network, LLC ("PHN") was selected to serve as the new contractor for pharmacy professionals recovery services, including comprehensive monitoring of applicable licensees and registrants.

This transition in service providers necessitates an amendment to prior Board Orders that mandated certain licensees and registrants contract with the Mississippi Association for Recovering Pharmacists ("MARF"). To ensure continuous and compliant monitoring under the previously ordered restrictions, affected Board Orders must be formally modified to replace all references to the Mississippi Association for Recovering Pharmacists ("MARF") with Professionals Health Network, LLC ("PHN") as the designated entity with which the licensee or registrant shall contract for monitoring services.

ACTION OF THE BOARD

The Board hereby amends the prior Board Orders (see attached) for the following list of licensees and registrants to replace all references to the Mississippi Association for Recovering Pharmacists ("MARF") with Professionals Health Network, LLC ("PHN") as the designated entity with which the licensee or registrant shall contract for monitoring services:







The Mississippi Board of Pharmacy (Board) has jurisdiction of the subject matter pursuant to Section 73-21-103(2), Mississippi Code of 1972, Annotated.

PROCEEDINGS

On September 16, 2021, the Board accepted the voluntary surrender and revoked the Petitioner's pharmacist license due to "addiction to or dependence on alcohol, controlled substances or other habit-forming legend drugs". Petitioner requests the Board reinstate her license. The Board heard testimony concerning the treatment and recovery of Petitioner.

ACTION OF THE BOARD

 - Petitioner shall abstain from the use of alcohol or the unauthorized use of controlled substances or other habit-forming legend drugs.
 - Petitioner shall not take any mood-altering drug which has not been prescribed for her.
 - Petitioner shall immediately inform the Board in writing (by email or fax) of all medications prescribed for her, stating the name of the drug, the number and strength of the doses prescribed, the dosage regimen and the name and registration number of the prescriber.
 - The Petitioner shall submit a urine specimen, serum specimen or hair sample when requested by the Board or any agent of the Board of Pharmacy.
 - Petitioner shall keep the Board informed at all times as to the place of her employment as a Pharmacist and any change in residential address.
 - Petitioner shall submit a written quarterly report (on a form prescribed by the Board) to the Board, due the first week of January, April, July and October, detailing her personal and professional well-being.

The Mississippi Board of Pharmacy has jurisdiction of the subject matter pursuant to Section 73-21-103(2), Mississippi Code of 1972, Annotated.

PROCEEDINGS

On September 20, 2018, Petitioner voluntarily surrendered his pharmacist license due to the addiction to controlled substances. Petitioner requests the Board reinstate his license. The Board heard testimony concerning the treatment and recovery of Petitioner.

ACTION OF THE BOARD

Based upon the clear and convincing evidence presented at the petition hearing, all members of the Board present voted to reinstate the Petitioner's license pursuant to all regulation requirements.

Prior to renewing his pharmacist license, Petitioner must:

- Obtain an intern registration and work as an intern for a Board approved pharmacist and site for (20) clock hours for each year that he has been without a valid license. Petitioner must provide a record from the supervising pharmacist showing satisfactory completion of sixty (60) hours as an intern.
- Provide proof of fifteen (15) hours of continuing education for the current licensing period.
- Pay all licensing fees in arrears.
- Satisfactorily pass the MPJE.

In addition, the Petitioner shall comply with the following conditions:

- The Petitioner shall enter into a ten (10) year Board approved contract with the Mississippi Association of Recovering Pharmacists (MARF) and comply with all terms of that contract. A copy of the contract shall be provided to the Mississippi Board of Pharmacy.
- The Petitioner shall be subject to the following conditions and restrictions indefinitely:
 - Petitioner shall abstain from the use of alcohol or the unauthorized use of controlled substances or other habit-forming legend drugs.
 - Petitioner shall not take any mood-altering drug which has not been prescribed for him.
 - Petitioner shall immediately inform the Board in writing (by email or fax) of all medications prescribed for him, stating the name of the drug, the number and

strength of the doses prescribed, the dosage regimen and the name and registration number of the prescriber.

That the Mississippi Board of Pharmacy has jurisdiction of the subject matter and person of Samuel T. Basil, pursuant to Section 73-21-97, paragraph (1), (f), Mississippi Code of 1972, Annotated.

STATEMENT OF CHARGES

COMPLAINT COUNT I

LICENSE TO PRACTICE PHARMACY NUMBER E-010537

On January 9, 2017, a "Notice of Hearing and Complaint" was issued on behalf of the Mississippi Board of Pharmacy by Frank E. Gammill, Jr., Executive Director of the Mississippi Board of Pharmacy, for service on Samuel T. Basil, Respondent, which "Complaint" charged Respondent with:

1. Violation of ARTICLE V, paragraph 1., F., ACTION AGAINST PHARMACIST LICENSE, of the Pharmacy Practice Regulations of the Mississippi Board of Pharmacy. Specifically, on or about June 7, 2016, the Respondent admitted to the unauthorized personal use of the controlled substance drug Adderall which he obtained without authorization and without a valid prescription.

PROCEEDINGS

This cause came before the Board for a Hearing on January 19, 2017, at 11:32 a.m., in the Board Meeting Room of the UBS Building, 6360 I-55 North, Suite 400, Jackson, Mississippi pursuant to said "Notice of Hearing and Complaint". The following members of the Board were present: James L. Calvert, President, John T. Barrett, Vice-President, Guy Phillips, Secretary, Phil Ayers, Clayton A. Farmer, Jillian Foster and Ryan Harper sitting in regular session of the Mississippi Board of Pharmacy. Mr. Calvert and Mr. Barrett did not participate due to their service on the Investigative Review Committee (IRC). The Honorable Geoffrey Morgan, with the office of Attorney General, served as Counsel for the Board. The Honorable David Scott served as Hearing Officer for the Board.

The Respondent, having personally appeared, stated that he had received a copy of the Notice of Hearing and Complaint, that he had read the same, and that he understood the charges. Respondent did not desire that there be a formal reading of the Complaint. Respondent indicated that he was ready to proceed with the hearing of the Charge contained in the Complaint.

The Board proceeded to hear testimony and evidence regarding the charge as contained in the "Notice of Hearing and Complaint". A true and correct copy of the Notice of Hearing and

Complaint, together with all exhibits attached thereto and incorporated therein as well as a true and correct copy of the Respondent Waiver, executed by Respondent on this date, whereby Respondent waives thirty (30) day notice prior to this hearing date, was offered into evidence by Counsel for the Board as Exhibits "1" and "2". The Respondent noted that there was no objection to the introduction of the same into the record.

The Board heard testimony and evidence presented by the Respondent, Counsel for the Board, Pharmacy Board Director of Compliance Cheri Atwood and Jerry Fortenberry representing the Mississippi Association of Recovering Pharmacists (MARP).

That the following FINDINGS OF FACT AND CONCLUSIONS OF LAW, as contained herein, are supported by substantial evidence that is clear and convincing; and

NOW, THEREFORE, PREMISES CONSIDERED, the Mississippi Board of Pharmacy, by unanimous vote of those members voting, finds;

FINDINGS OF FACT

- (1) That the Respondent was properly notified of the charges by a duly processed Notice of Hearing and Complaint as provided for in Section 73-21-99, Mississippi Code of 1972, Annotated; and
- (2) That the Respondent was properly advised of the charges both by having been duly served with the "Notice of Hearing and Complaint" and affidavits in this matter and by having the charges introduced into the record of these PROCEEDINGS; and
- (3) That the Respondent, having been advised of his right to subpoena witnesses and documents, to cross examine witnesses, present testimony, evidence and arguments and of his right to the assistance of an attorney, chose not to have counsel to assist him; and
- (4) That as to paragraphs A. and B., of the "Notice of Hearing and Complaint", the Board FINDS AS A FACT, that the Respondent was issued a license to practice pharmacy by the Board, Certificate of Registration Number E-010537, and as such was subject to the jurisdiction of the Board pursuant to Section 73-21-97, paragraph (1), (f), Mississippi Code of 1972, Annotated; and
- (5) That as to paragraph C., of the "Notice of Hearing and Complaint", the Board FINDS AS A FACT that testimony from Pharmacy Board Director of Compliance Cheri Atwood, the AFFIDAVIT of Pharmacy Board Director of Compliance Cheri Atwood and the Respondent's oral statements to the Board and other documented evidence as entered into the official record of these PROCEEDINGS established that Respondent had admitted to the unauthorized personal use of the controlled substance drug Adderall which he obtained without authorization and without a valid prescription; and
- (6) That Jerry Fortenberry, representing the Mississippi Association of Recovering Pharmacists (MARP), advocated for Respondent's return to the active practice of pharmacy.

NOW, THEREFORE, PREMISES CONSIDERED, the Board does take the following ACTION:

ACTION OF THE BOARD

That after hearing and considering oral testimony and all other evidence introduced into the official record, a motion was made in open session by Mr. Phillips and seconded by Mr. Farmer to approve the FINAL ORDER OF THE BOARD and to sustain the charge as outlined above and as contained in the "Notice of Hearing and Complaint" as entered into the official

record. With Mr. Phillips, Mr. Farmer, Mr. Ayers, Mr. Harper and Ms. Foster voting “YES” and with Mr. Calvert and Mr. Barrett “RECUSED”, the motion passed; and

CONCLUSIONS

FURTHER, the Board finds, as noted by the specific findings as listed above, as well as from the evidence presented as a whole, that there is **substantial evidence** that is **clear and convincing** to support the charges as outlined above and as listed in the “Notice of Hearing and Complaint”.

IT IS ORDERED:

FINAL ORDER OF THE BOARD

That this ORDER OF THE BOARD is effective immediately and that the Executive Director, Frank E. Gammill, Jr., cause a certified copy of these PROCEEDINGS and this ORDER of the Board to be served on the Respondent and a copy placed in his personal file in the office of the Board; and

That the Pharmacist License (Certificate of Registration Number E-010537) issued to Samuel T. Basil, is hereby REINSTATED and placed on probation FOR A PERIOD OF TEN (10) YEARS. That during said PROBATION, Respondent is to be under contract with the Mississippi Association of Recovering Pharmacists (MARP) and must abide with all provisions of the MARP contract; and

That pursuant to Section 73-21-103, paragraph (1), (d), (iii), Respondent shall pay the cost of investigation in the amount of \$501.15. Said monetary penalty is due and payable in the office of the Board within 30 days of receipt of Notice of Board Action; and

That Respondent shall notify the Board of any employment as a pharmacist and that Respondent shall disclose any and all matters as contained in these proceedings to any prospective employer; and

Further, that the following conditions and restrictions are placed on Respondent:

- (1) That Respondent abstain from the use of alcohol or the unauthorized use of controlled substances or other habit forming legend drugs; and
- (2) That for an indefinite period of time, Respondent submit a urine specimen when requested by the Board or any agent of the Board of Pharmacy; and
- (3) That for an indefinite period of time, Respondent submit a serum specimen when requested by the Board or any agent of the Board of Pharmacy; and
- (4) That for an indefinite period of time, Respondent submit a hair sample when requested by the Board or any agent of the Board of Pharmacy; and
- (5) That during the period of probation, Respondent must keep the Board informed at all times as to the time and place of his employment as a Pharmacist; and further, that he submit a quarterly report in writing to the Board detailing personal and professional well being; and
- (6) That during the period of probation, Respondent shall not take any drug, which has not been prescribed for him. That, except in an emergency, before ingesting any drug which has been prescribed, Respondent shall inform the Executive Director or a Compliance Agent orally, by phone or by other means. That he follow this by written notice to the Executive Director of the Board within twenty-four (24) hours, stating the name of the drug ingested, the number and strength of the doses prescribed, the dosage regimen and the name and registration number of the prescriber; and

- (7) That Respondent shall be in compliance with all state and federal laws and regulations of the Board; and
- (8) Further, that Respondent's Failure to Comply with the Order of the Board or his Contract with the Mississippi Association of Recovering Pharmacists (MARF) will result in the immediate suspension of his Pharmacist License.

JURISDICTION

The Mississippi Board of Pharmacy has jurisdiction of the subject matter pursuant to Section 73-21-103(2), Mississippi Code of 1972, Annotated.

PROCEEDINGS

Petitioner requested reinstatement of his Pharmacist license, Certificate of Registration Number E-08545. Petitioner's license was revoked in November 2017 due to failure to follow an Order of the Board.

ACTION OF THE BOARD

Based upon the clear and convincing evidence presented at the petition hearing, all members of the Board present voted to approve the request of the Petitioner and reinstate Pharmacist License, Certificate of Registration Number E-08545 with the following conditions:

- The Petitioner shall not be allowed to perform the duties of Pharmacist in Charge (PIC) at any pharmacy permitted by the Board;
- The Petitioner shall provide proof of ten (10) hours of continuing education for 2017 and ten (10) hours of continuing education for 2018;
- Pursuant to Section 73-21-103 (1)(d)(iii), Petitioner shall pay the cost of investigation in the amount of One Thousand Eight Hundred Ninety-Three Dollars and Fifty-One Cents (\$1893.51). Payment may be made pursuant to a payment plan established by Board staff;
- The Petitioner's license shall be placed on probation for ten (10) years beginning May 17, 2018 and expiring May 16, 2028;
- The Petitioner shall enter into a ten (10) year contract with the Mississippi Association of Recovering Pharmacists (MARP) and comply with all terms of that contract. The contract shall include counselling sessions. A copy of the contract shall be provided to the Mississippi Board of Pharmacy;
- The Petitioner shall be subject to the following conditions and restrictions during the probationary period:
 - Petitioner shall abstain from the use of alcohol or the unauthorized use of controlled substances or other habit-forming legend drugs;
 - Petitioner shall not take any mood-altering drug which has not been prescribed for her;
 - Petitioner shall immediately inform the Board in writing (by email or fax) of all medications prescribed for her, stating the name of the drug, the number and

strength of the doses prescribed, the dosage regimen and the name and registration number of the prescriber;

- The Petitioner shall submit a urine specimen, serum specimen or hair sample when requested by the Board or any agent of the Board of Pharmacy;
- Petitioner shall keep the Board informed at all times as to place of her employment as a Pharmacist and any change in residential address;

COMPLAINT COUNT I

LICENSE TO PRACTICE PHARMACY NUMBER E-09972

On March 1, 2016, a "Notice of Hearing and Complaint" was issued on behalf of the Mississippi Board of Pharmacy by Frank E. Gammill, Jr., Executive Director of the Mississippi Board of Pharmacy, for service on Robert M. Jordan, Respondent, which "Complaint" charged Respondent with:

1. Violation of ARTICLE V, paragraph 1., F., ACTION AGAINST PHARMACIST LICENSE, of the Pharmacy Practice Regulations of the Mississippi Board of Pharmacy. Specifically, on June 23, 2015, the Respondent admitted to obtaining the controlled substance drug Klonopin, without authorization for personal use, by alteration to prescription documents.

PROCEEDINGS

This cause came before the Board for a Hearing on March 24, 2016, at 10:08 a.m., in the Board Meeting Room of the UBS Building, 6360 I-55 North, Suite 400, Jackson, Mississippi pursuant to said "Notice of Hearing and Complaint". The following members of the Board were present: James L. Calvert, President, Guy Phillips, Secretary, Waymon Tigrett, John T. Barrett, Clayton A. Farmer and Phil Ayers sitting in regular session of the Mississippi Board of Pharmacy. Mr. Barrett and Mr. Calvert did not participate due to their service on the Investigative Review Committee (IRC). The Honorable Geoffrey Morgan, with the office of Attorney General, served as Counsel for the Board. The Honorable David Scott, with the office of Attorney General, served as Hearing Officer for the Board.

The Respondent, having personally appeared, stated that he had received a copy of the Notice of Hearing and Complaint, that he had read the same, and that he understood the charges. Respondent acknowledged that he understood his right to be represented by counsel and waived that right. Respondent did not desire that there be a formal reading of the Complaint. Respondent indicated that he was ready to proceed with the hearing of the Charge contained in the Complaint.

The Board proceeded to hear testimony and evidence regarding the charge as contained in the "Notice of Hearing and Complaint". The Respondent noted that there was no objection to the introduction of the same into the record.

The Board heard testimony and evidence presented by the Respondent, Counsel for the Board, Pharmacy Board Compliance Agent Sid Seal and Jerry Fortenberry representing the Mississippi Association of Recovering Pharmacists (MARF).

That the following FINDINGS OF FACT AND CONCLUSIONS OF LAW, as contained herein, are supported by substantial evidence that is clear and convincing; and

NOW, THEREFORE, PREMISES CONSIDERED, the Mississippi Board of Pharmacy, by unanimous vote of those members voting, finds;

FINDINGS OF FACT

- (1) That the Respondent was properly notified of the charges by a duly processed Notice of Hearing and Complaint as provided for in Section 73-21-99, Mississippi Code of 1972, Annotated; and
- (2) That the Respondent was properly advised of the charges both by having been duly served with the "Notice of Hearing and Complaint" and affidavits in this matter and by having the charges introduced into the record of these PROCEEDINGS; and
- (3) That the Respondent, having been advised of his right to subpoena witnesses and documents, to cross examine witnesses, present testimony, evidence and arguments and of his right to the assistance of an attorney, chose not to have counsel to assist him; and
- (4) That as to paragraphs A. and B., of the "Notice of Hearing and Complaint", the Board FINDS AS A FACT, that the Respondent was issued a license to practice pharmacy by the Board, Certificate of Registration Number E-09972, and as such was subject to the jurisdiction of the Board pursuant to Section 73-21-97, paragraph (1), (f), Mississippi Code of 1972, Annotated; and
- (5) That as to paragraph C., of the "Notice of Hearing and Complaint", the Board FINDS AS A FACT that testimony from Pharmacy Board Compliance Agent Sid Seal, the AFFIDAVIT of Pharmacy Board Compliance Agent Sid Seal and the Respondent's oral statements to the Board and other documented evidence as entered into the official record of these PROCEEDINGS, established that Respondent had admitted to obtaining the controlled substance drug Klonopin, without authorization for personal use, by alteration to prescription documents.
- (6) That Jerry Fortenberry, representing the Mississippi Association of Recovering Pharmacists (MARF), advocated for Respondent's return to the active practice of pharmacy.

NOW, THEREFORE, PREMISES CONSIDERED, the Board does take the following ACTION:

ACTION OF THE BOARD

That after hearing and considering oral testimony and all other evidence introduced into the official record, a motion was made in open session by Mr. Tigrett and seconded by Mr. Ayers to approve the FINAL ORDER OF THE BOARD and to sustain the charge as outlined above and as contained in the "Notice of Hearing and Complaint" as entered into the official record. With Mr. Tigrett, Mr. Ayers, Mr. Phillips and Mr. Farmer voting "YES", and with Mr. Barrett and Mr. Calvert "RECUSED", the motion passed; and

CONCLUSIONS

FURTHER, the Board finds, as noted by the specific findings as listed above, as well as from the evidence presented as a whole, that there is **substantial evidence** that is **clear and convincing** to support the charge as outlined above and as listed in the "Notice of Hearing and Complaint".

STATEMENT OF CHARGES

COMPLAINT COUNT I

LICENSE TO PRACTICE PHARMACY NUMBER E-06260

On November 7, 2016, a "Notice of Hearing and Complaint" was issued on behalf of the Mississippi Board of Pharmacy by Frank E. Gammill, Jr., Executive Director of the Mississippi Board of Pharmacy, for service on Danny R. Myers, Respondent, which "Complaint" charged Respondent with:

1. Violation of ARTICLE V, paragraph 1., F., ACTION AGAINST PHARMACIST LICENSE, of the Pharmacy Practice Regulations of the Mississippi Board of Pharmacy. Specifically, on April 18, 2016, the Respondent made a voluntary surrender of his Pharmacist License based on his unauthorized use of controlled substances which he obtained without authorization and without a valid prescription.

PROCEEDINGS

This cause came before the Board for a Hearing on November 17, 2016, at 12:41 p.m., in the Board Meeting Room of the UBS Building, 6360 I-55 North, Suite 400, Jackson, Mississippi pursuant to said "Notice of Hearing and Complaint". The following members of the Board were present: James L. Calvert, President, John T. Barrett, Vice-President, Guy Phillips, Secretary, Phil Ayers, Jillian Foster and Ryan Harper sitting in regular session of the Mississippi Board of Pharmacy. Board Vice President John T. Barrett was RECUSED from the proceedings. Board Member Clayton A. Farmer was not present. The Honorable Geoffrey Morgan, with the office of Attorney General, served as Counsel for the Board. The Honorable David Scott served as Hearing Officer for the Board.

The Respondent, having personally appeared, stated that he had received a copy of the Notice of Hearing and Complaint, that he had read the same, and that he understood the charges. Respondent did not desire that there be a formal reading of the Complaint. Respondent indicated that he was ready to proceed with the hearing of the Charge contained in the Complaint.

The Board proceeded to hear testimony and evidence regarding the charges as contained in the "Notice of Hearing and Complaint". A true and correct copy of the Notice of Hearing and Complaint, together with all exhibits attached thereto and incorporated therein as well as a true and correct copy of the Respondent Waiver, executed by Respondent on this date, whereby Respondent waives thirty (30) day notice prior to this hearing date, was offered into evidence by

Counsel for the Board as Exhibits "1" and "2". The Respondent noted that there was no objection to the introduction of the same into the record.

The Board heard testimony and evidence presented by the Respondent, Counsel for the Board, Pharmacy Board Director of Compliance Cheri Atwood and Jerry Fortenberry representing the Mississippi Association of Recovering Pharmacists (MARP).

That the following FINDINGS OF FACT AND CONCLUSIONS OF LAW, as contained herein, are supported by substantial evidence that is clear and convincing; and

NOW, THEREFORE, PREMISES CONSIDERED, the Mississippi Board of Pharmacy, by unanimous vote of those members voting, finds;

FINDINGS OF FACT

- (1) That the Respondent was properly notified of the charges by a duly processed Notice of Hearing and Complaint as provided for in Section 73-21-99, Mississippi Code of 1972, Annotated; and
- (2) That the Respondent was properly advised of the charges both by having been duly served with the "Notice of Hearing and Complaint" and affidavits in this matter and by having the charges introduced into the record of these PROCEEDINGS; and
- (3) That the Respondent, having been advised of his right to subpoena witnesses and documents, to cross examine witnesses, present testimony, evidence and arguments and of her right to the assistance of an attorney, chose not to have counsel to assist him; and
- (4) That as to paragraphs A. and B., of the "Notice of Hearing and Complaint", the Board FINDS AS A FACT, that the Respondent was issued a license to practice pharmacy by the Board, Certificate of Registration Number E-06260, and as such was subject to the jurisdiction of the Board pursuant to Section 73-21-97, paragraph (1), (f), Mississippi Code of 1972, Annotated; and
- (5) That as to paragraph C., of the "Notice of Hearing and Complaint", the Board FINDS AS A FACT that testimony from Pharmacy Board Director of Compliance Cheri Atwood, the AFFIDAVIT of Pharmacy Board Director of Compliance Cheri Atwood and the Respondent's oral statements to the Board and other documented evidence as entered into the official record of these PROCEEDINGS established that Respondent had admitted to the unauthorized personal use of the controlled substance drugs hydrocodone and alprazolam, which he obtained without authorization and without a valid prescription; and
- (6) That Jerry Fortenberry, representing the Mississippi Association of Recovering Pharmacists (MARP), advocated for Respondent's return to the active practice of pharmacy.

NOW, THEREFORE, PREMISES CONSIDERED, the Board does take the following ACTION:

ACTION OF THE BOARD

That after hearing and considering oral testimony and all other evidence introduced into the official record, a motion was made in open session by Mr. Phillips and seconded by Mr. Ayers to approve the FINAL ORDER OF THE BOARD and to sustain the charge as outlined above and as contained in the "Notice of Hearing and Complaint" as entered into the official record. With Mr. Phillips, Mr. Ayers, Mr. Calvert, Mr. Harper and Ms. Foster voting "YES" and with Mr. Barrett "RECUSED" the motion passed; and

CONCLUSIONS

FURTHER, the Board finds, as noted by the specific findings as listed above, as well as from the evidence presented as a whole, that there is **substantial evidence** that is **clear and convincing** to support the charges as outlined above and as listed in the "Notice of Hearing and Complaint".

STATEMENT OF CHARGES

COMPLAINT COUNT I

LICENSE TO PRACTICE PHARMACY NUMBER E-07526

On November 7, 2016, a "Notice of Hearing and Complaint" was issued on behalf of the Mississippi Board of Pharmacy by Frank E. Gammill, Jr., Executive Director of the Mississippi Board of Pharmacy, for service on Melissa A. Andrews, Respondent, which "Complaint" charged Respondent with:

1. Violation of ARTICLE V, paragraph 1., F., ACTION AGAINST PHARMACIST LICENSE, of the Pharmacy Practice Regulations of the Mississippi Board of Pharmacy. Specifically, on March 28, 2016, the Respondent admitted to the theft and unauthorized personal use of the controlled substance drugs buprenorphine and methadone, which she obtained without authorization and without a valid prescription from the institutional pharmacy where she was employed as a pharmacist.

PROCEEDINGS

This cause came before the Board for a Hearing on November 17, 2016, at 11:12 a.m., in the Board Meeting Room of the UBS Building, 6360 I-55 North, Suite 400, Jackson, Mississippi pursuant to said "Notice of Hearing and Complaint". The following members of the Board were present: James L. Calvert, President, John T. Barrett, Vice-President, Guy Phillips, Secretary, Phil Ayers, Jillian Foster and Ryan Harper sitting in regular session of the Mississippi Board of Pharmacy. Board Member Clayton A. Farmer was not present. The Honorable Geoffrey Morgan, with the office of Attorney General, served as Counsel for the Board. The Honorable David Scott served as Hearing Officer for the Board.

The Respondent, having personally appeared, stated that she had received a copy of the Notice of Hearing and Complaint, that she had read the same, and that she understood the charges. Respondent did not desire that there be a formal reading of the Complaint. Respondent indicated that she was ready to proceed with the hearing of the Charge contained in the Complaint.

The Board proceeded to hear testimony and evidence regarding the charges as contained in the "Notice of Hearing and Complaint". A true and correct copy of the Notice of Hearing and Complaint, together with all exhibits attached thereto and incorporated therein as well as a true

and correct copy of the Respondent Waiver, executed by Respondent on this date, whereby Respondent waives thirty (30) day notice prior to this hearing date, was offered into evidence by Counsel for the Board as Exhibits “1” and “2”. The Respondent noted that there was no objection to the introduction of the same into the record.

The Board heard testimony and evidence presented by the Respondent, Counsel for the Board, Pharmacy Board Director of Compliance Cheri Atwood, Pharmacy Board Compliance Agent Gerald Pugh and Jerry Fortenberry and Steve Wilson representing the Mississippi Association of Recovering Pharmacists (MARP).

That the following FINDINGS OF FACT AND CONCLUSIONS OF LAW, as contained herein, are supported by substantial evidence that is clear and convincing; and

NOW, THEREFORE, PREMISES CONSIDERED, the Mississippi Board of Pharmacy, by unanimous vote of those members voting, finds;

FINDINGS OF FACT

- (1) That the Respondent was properly notified of the charges by a duly processed Notice of Hearing and Complaint as provided for in Section 73-21-99, Mississippi Code of 1972, Annotated; and
- (2) That the Respondent was properly advised of the charges both by having been duly served with the “Notice of Hearing and Complaint” and affidavits in this matter and by having the charges introduced into the record of these PROCEEDINGS; and

- (6) That Jerry Fortenberry and Steve Wilson, representing the Mississippi Association of Recovering Pharmacists (MARP), advocated for Respondent’s return to the active practice of pharmacy.

NOW, THEREFORE, PREMISES CONSIDERED, the Board does take the following ACTION:

ACTION OF THE BOARD

That after hearing and considering oral testimony and all other evidence introduced into the official record, a motion was made in open session by Mr. Barrett and seconded by Mr.

Ayers to approve the FINAL ORDER OF THE BOARD and to sustain the charge as outlined above and as contained in the "Notice of Hearing and Complaint" as entered into the official record. With Mr. Barrett, Mr. Ayers, Mr. Calvert, Mr. Phillips, Mr. Harper and Ms. Foster voting "YES" the motion passed; and

CONCLUSIONS

FURTHER, the Board finds, as noted by the specific findings as listed above, as well as from the evidence presented as a whole, that there is **substantial evidence** that is **clear and convincing** to support the charges as outlined above and as listed in the "Notice of Hearing and Complaint".

CONCLUSIONS OF LAW

That the Mississippi Board of Pharmacy has jurisdiction of the subject matter and person of Leann R. Williams, pursuant to Section 73-21-97, paragraph (1), (f), Mississippi Code of 1972, Annotated.

STATEMENT OF CHARGES

COMPLAINT COUNT I

LICENSE TO PRACTICE PHARMACY NUMBER E-08187

On September 14, 2016, a "Notice of Hearing and Complaint" was issued on behalf of the Mississippi Board of Pharmacy by Frank E. Gammill, Jr., Executive Director of the Mississippi Board of Pharmacy, for service on Leann R. Williams, Respondent, which "Complaint" charged Respondent with:

1. Violation of ARTICLE V, paragraph 1., F., ACTION AGAINST PHARMACIST LICENSE, of the Pharmacy Practice Regulations of the Mississippi Board of Pharmacy. Specifically, on June 4, 2015, the Respondent admitted to obtaining the controlled substance drugs hydrocodone and Adderall, without authorization and without a valid prescription from the community independent pharmacy where she was employed as a pharmacist.
2. Violation of Section 73-21-97, paragraph (1), (e), of the Mississippi Code of 1972, Annotated. Specifically, Respondent engaged in the practice of Pharmacy without a current Pharmacist License.

PROCEEDINGS

This cause came before the Board for a Hearing on September 15, 2016, at 12:49 p.m., in the Board Meeting Room of the UBS Building, 6360 I-55 North, Suite 400, Jackson, Mississippi pursuant to said "Notice of Hearing and Complaint". The following members of the Board were present: James L. Calvert, President, Guy Phillips, Secretary, Clayton A. Farmer, Phil Ayers, Jillian Foster and Ryan Harper sitting in regular session of the Mississippi Board of Pharmacy. Board Vice President John T. Barrett was not present. Mr. Calvert did not participate due to his service on the Investigative Review Committee (IRC). The Honorable Geoffrey Morgan, with the office of Attorney General, served as Counsel for the Board. The Honorable David Scott served as Hearing Officer for the Board.

The Respondent, having personally appeared, stated that she had received a copy of the Notice of Hearing and Complaint, that she had read the same, and that she understood the

charges. Respondent acknowledged that she understood her right to be represented by counsel and waived that right. Respondent did not desire that there be a formal reading of the Complaint. Respondent indicated that she was ready to proceed with the hearing of the Charge contained in the Complaint.

The Board proceeded to hear testimony and evidence regarding the charges as contained in the "Notice of Hearing and Complaint". A true and correct copy of the Notice of Hearing and Complaint, together with all exhibits attached thereto and incorporated therein as well as a true and correct copy of the Respondent Waiver, executed by Respondent on this date, whereby Respondent waives thirty (30) day notice prior to this hearing date, was offered into evidence by Counsel for the Board as Composite Exhibit "1". The Respondent noted that there was no objection to the introduction of the same into the record.

The Board heard testimony and evidence presented by the Respondent, Counsel for the Board, Pharmacy Board Compliance Agent Susan McCoy and Steve Wilson representing the Mississippi Association of Recovering Pharmacists (MARF).

A motion was made by Mr. Phillips that the meeting be closed to determine whether or not the Board should declare an Executive Session. With Mr. Phillips, Mr. Ayers, Mr. Farmer, Ms. Foster and Mr. Harper voting "YES", and with Mr. Calvert "RECUSED" the motion to close the meeting was approved.

A motion was made by Mr. Phillips that the Board enter executive session to deliberate and/or discuss investigative proceedings regarding allegations of misconduct or violation of law in the Complaint of the Mississippi Board of Pharmacy vs Leann R. Williams. A second to the motion was made by Mr. Harper and with Mr. Phillips, Mr. Harper, Mr. Ayers, Mr. Farmer and Ms. Foster voting "YES" and with Mr. Calvert "RECUSED", the motion to enter executive session was approved. The Board is now in executive session.

After deliberation in executive session a motion was made by Mr. Ayers to return to open session. A second to the motion was made by Mr. Farmer and with Mr. Ayers, Mr. Farmer, Mr. Phillips, Ms. Foster and Mr. Harper voting "YES" and with Mr. Calvert "RECUSED", the motion to return to open session was approved. The Board returned to open session. No action was taken in Executive Session.

As a result of the Executive Session, the following FINDINGS OF FACT AND CONCLUSIONS OF LAW were made, as contained herein, and are supported by substantial evidence that is clear and convincing; and

NOW, THEREFORE, PREMISES CONSIDERED, the Mississippi Board of Pharmacy, by unanimous vote of those members voting, finds;

FINDINGS OF FACT

- (1) That the Respondent was properly notified of the charges by a duly processed Notice of Hearing and Complaint as provided for in Section 73-21-99, Mississippi Code of 1972, Annotated; and
- (2) That the Respondent was properly advised of the charges both by having been duly served with the "Notice of Hearing and Complaint" and affidavits in this matter and by having the charges introduced into the record of these PROCEEDINGS; and
- (3) That the Respondent, having been advised of her right to subpoena witnesses and documents, to cross examine witnesses, present testimony, evidence and arguments and of her right to the assistance of an attorney, chose not to have counsel to assist her; and

- (4) That as to paragraphs A. and B., of the “Notice of Hearing and Complaint”, the Board FINDS AS A FACT, that the Respondent was issued a license to practice pharmacy by the Board, Certificate of Registration Number E-08187, and as such was subject to the jurisdiction of the Board pursuant to Section 73-21-97, paragraph (1), (f), Mississippi Code of 1972, Annotated; and
- (5) That as to paragraph C., of the “Notice of Hearing and Complaint”, the Board FINDS AS A FACT that testimony from Pharmacy Board Compliance Agent Susan McCoy, the AFFIDAVIT of Pharmacy Board Compliance Agent Susan McCoy and the Respondent’s oral statements to the Board and other documented evidence as entered into the official record of these PROCEEDINGS established that Respondent had admitted to obtaining the controlled substance drugs hydrocodone and Adderall, without authorization and without a valid prescription, from the community chain pharmacy where she was employed; and
- (6) That as to paragraph D., of the “Notice of Hearing and Complaint”, the Board FINDS AS A FACT that testimony from Pharmacy Board Compliance Agent Susan McCoy, the AFFIDAVIT of Pharmacy Board Compliance Agent Susan McCoy and the Respondent’s oral statements to the Board and other documented evidence as entered into the official record of these PROCEEDINGS established that Respondent had admitted to engaging in the practice of pharmacy without a current Pharmacist License; and
- (7) That Steve Wilson, representing the Mississippi Association of Recovering Pharmacists (MARP), advocated for Respondent’s return to the active practice of pharmacy.

NOW, THEREFORE, PREMISES CONSIDERED, the Board does take the following ACTION:

ACTION OF THE BOARD

That after hearing and considering oral testimony and all other evidence introduced into the official record, a motion was made in open session by Mr. Phillips and seconded by Mr. Harper to approve the FINAL ORDER OF THE BOARD and to sustain the charges as outlined above and as contained in the “Notice of Hearing and Complaint” as entered into the official record. With Mr. Phillips, Mr. Harper, Mr. Farmer and Ms. Foster voting “YES”, and with Mr. Calvert and Mr. Ayers “RECUSED”, the motion passed; and

CONCLUSIONS

FURTHER, the Board finds, as noted by the specific findings as listed above, as well as from the evidence presented as a whole, that there is **substantial evidence** that is **clear and convincing** to support the charges as outlined above and as listed in the “Notice of Hearing and Complaint”.

IT IS ORDERED:

FINAL ORDER OF THE BOARD

That this ORDER OF THE BOARD is effective immediately and that the Executive Director, Frank E. Gammill, Jr., cause a certified copy of these PROCEEDINGS and this ORDER of the Board to be served on the Respondent and a copy placed in her personal file in the office of the Board; and

That the Pharmacist License (Certificate of Registration Number E-08187) issued to Leann R. Williams, is hereby REINSTATED and placed on probation FOR A PERIOD OF TEN

JURISDICTION

The Mississippi Board of Pharmacy (Board) has jurisdiction of the subject matter pursuant to Section 73-21-103(2), Mississippi Code of 1972, Annotated.

PROCEEDINGS

On September 15, 2016, the Board entered an Order which reinstated the license of the Petitioner under probation and a ten (10) year MARP contract. Petitioner has requested the Board to remove probation from her license.

ACTION OF THE BOARD

Based upon the clear and convincing evidence presented at the petition hearing, all members of the Board present voted to remove the remainder probation from the Petitioner's license. All other terms and conditions of the September 15, 2016 Board Order shall remain effective.

A certified copy of this ORDER shall be served on the Petitioner and maintained in the office of the Board.

(10) YEARS. That during said PROBATION, Respondent is to be under contract with the Mississippi Association of Recovering Pharmacists (MARP) and must abide with all provisions of the MARP contract; and

That pursuant to Section 73-21-103, paragraph (1), (d), (iii), Respondent shall pay the cost of investigation in the amount of \$1,971.04. Said monetary penalty is due and payable in the office of the Board within 90 days of receipt of Notice of Board Action; and

That pursuant to Section 73-21-103, paragraph (1), (d), (ii), Respondent shall pay a monetary penalty in the amount of one-thousand dollars (\$1,000.00) for the first violation of the Pharmacy Practice Regulations, as listed in Paragraph C. of the Notice of Hearing and Complaint, and a monetary penalty in the amount of five-thousand dollars (\$5,000.00) for the second violation of the Pharmacy Practice Regulations as listed in Paragraph D. of the Notice of Hearing and Complaint for a total monetary penalty of \$6,000.00. Said monetary penalty is due and payable in the office of the Board within 90 days of receipt of Notice of Board Action.

That Respondent shall notify the Board of any employment as a pharmacist and that Respondent shall disclose any and all matters as contained in these proceedings to any prospective employer; and

Further, that the following conditions and restrictions are placed on Respondent:

- (1) That Respondent abstain from the use of alcohol or the unauthorized use of controlled substances or other habit forming legend drugs; and
- (2) That for an indefinite period of time, Respondent submit a urine specimen when requested by the Board or any agent of the Board of Pharmacy; and
- (3) That for an indefinite period of time, Respondent submit a serum specimen when requested by the Board or any agent of the Board of Pharmacy; and
- (4) That for an indefinite period of time, Respondent submit a hair sample when requested by the Board or any agent of the Board of Pharmacy; and
- (5) That during the period of probation, Respondent must keep the Board informed at all times as to the time and place of her employment as a Pharmacist; and further, that she submit a quarterly report in writing to the Board detailing personal and professional well being; and
- (6) That during the period of probation, Respondent shall not take any drug, which has not been prescribed for her. That, except in an emergency, before ingesting any drug which has been prescribed, Respondent shall inform the Executive Director or a Compliance Agent orally, by phone or by other means. That she follow this by written notice to the Executive Director of the Board within twenty-four (24) hours, stating the name of the drug ingested, the number and strength of the doses prescribed, the dosage regimen and the name and registration number of the prescriber; and
- (7) That Respondent shall be in compliance with all state and federal laws and regulations of the Board; and
- (8) Further, that Respondent's Failure to Comply with the Order of the Board or her Contract with the Mississippi Association of Recovering Pharmacists (MARP) will result in the immediate suspension of her Pharmacist License.

JURISDICTION

The Mississippi Board of Pharmacy has jurisdiction of the subject matter pursuant to Section 73-21-103(2), Mississippi Code of 1972, Annotated.

PROCEEDINGS

The Mississippi Board of Pharmacy entered an Order on February 17, 2022, which revoked the license of the Petitioner for addiction to or dependence on alcohol, controlled substances or other habit-forming legend drugs or the unauthorized use, possession or theft of controlled substances or other habit-forming legend drugs. The Board also imposed a penalty in the amount of Two Thousand Dollars (\$2,000.00) and charged the Respondent for the cost of investigation in the amount of Two Hundred and Fifty Dollars (\$250.00). On September 15, 2022, the Petitioner appeared before the Board with a request to reinstate the license of the Petitioner. No action was taken by the Board and the request of the Petitioner was denied. The Petitioner requests the Board to reinstate his license and allow him to pay the Two Thousand Two Hundred and Fifty Dollars (\$2,250.00) penalty and costs issued in the February 17, 2022, Board Order over a twelve (12) month payment period.

The Board heard testimony concerning the request of the Petitioner.

ACTION OF THE BOARD

Based upon the clear and convincing evidence presented at the petition hearing, all members of the Board present voted to reinstate the Petitioner's license and to allow payment of the penalty and costs imposed in the February 17, 2022, Board Order in equal installments, over a twelve (12) month payment period.

The Petitioner shall be subject to the following conditions and restrictions:

- The Petitioner shall enter into a contract with the Mississippi Association of Recovering Pharmacists ("MARF") and comply with the terms of that contract, which shall include random drug and alcohol screens, including the use of Peth blood alcohol testing and hair sample testing. The MARF contract shall expire ten (10) years from the date of this Order.
- Petitioner shall abstain from the use of alcohol or the unauthorized use of controlled substances or other habit-forming legend drugs.
- Petitioner shall not take any mood-altering drug which has not been prescribed for him.

- Petitioner shall immediately inform the Board in writing (by email or fax) of all medications prescribed for him, stating the name of the drug, the number and strength of the doses prescribed, the dosage regimen and the name and registration number of the prescriber.
- The Petitioner shall submit a urine specimen, serum specimen or hair sample when requested by the Board or any agent of the Board of Pharmacy.
- The Petitioner shall only work day shifts.
- The Petitioner's access to controlled medications shall be monitored.
- The Petitioner is not authorized to work in a pharmacy alone, but rather shall work with another pharmacist.
- The Petitioner is not authorized to have a key to the pharmacy in which he works.
- The Petitioner is not authorized to work in a supervisory role.
- The Petitioner shall have a workplace monitor who is informed by the Petitioner of his history in order to be adequately observed in the workplace.
- The Petitioner is not authorized to work more than fifty (50) hours per week.
- Petitioner shall keep the Board informed at all times as to place of his employment as a Pharmacist and any change in residential address.

JURISDICTION

The Mississippi Board of Pharmacy has jurisdiction of the subject matter pursuant to Section 73-21-103(2), Mississippi Code of 1972, Annotated.

PROCEEDINGS

The Mississippi Board of Pharmacy entered an Order on February 17, 2022, which revoked the license of the Petitioner for addiction to or dependence on alcohol, controlled substances or other habit-forming legend drugs or the unauthorized use, possession or theft of controlled substances or other habit-forming legend drugs. The Board also imposed a penalty in the amount of Two Thousand Dollars (\$2,000.00) and charged the Respondent for the cost of investigation in the amount of Two Hundred and Fifty Dollars (\$250.00). On September 15, 2022, the Petitioner appeared before the Board with a request to reinstate the license of the Petitioner. No action was taken by the Board and the request of the Petitioner was denied. On March 23, 2023, the Petitioner appeared before the Board with a request to reinstate the license of Petitioner. The Board affirmed the request and reinstated the license of the Petitioner with several restrictions and allowed him to pay the Two Thousand Two Hundred and Fifty Dollars (\$2,250.00) penalty and costs issued in the February 17, 2022, Board Order over a twelve (12) month payment period. On September 21, 2023, Petitioner appeared before the Board with a request to remove the restrictions on his license. The Board denied the request of the Petitioner and ordered the Petitioner not appear before the Board on the matter until at least one (1) year from the date of the Order. The Petitioner requests the Board remove some of the restrictions on his license.

The Board heard testimony concerning the request of the Petitioner.

ACTION OF THE BOARD

Based upon the clear and convincing evidence presented at the petition hearing, all members of the Board present voted to approve the request by the Petitioner to remove the following restrictions on his license:

- The Petitioner shall only work day shifts.
- The Petitioner is not authorized to work in a pharmacy alone, but rather shall work with another pharmacist.
- The Petitioner is not authorized to have a key to the pharmacy in which he works.
- The Petitioner shall have a workplace monitor who is informed by the Petitioner of his history in order to be adequately observed in the workplace.

The following restriction is added on the license of the Petitioner:

- The Petitioner is only authorized to practice pharmacy at Home Care Medical, Pharmacy Permit Number 05882/2.0 and Advanced Medical Inc., Pharmacy Permit Number 18519/2.0.

The following restrictions remain in effect:


- The Petitioner shall enter into a contract with the Mississippi Association of Recovering Pharmacists (“MARP”) and comply with the terms of that contract, which shall include random drug and alcohol screens, including the use of Peth blood alcohol testing and hair sample testing. The MARP contract shall expire on March 22, 2033.
- Petitioner shall abstain from the use of alcohol or the unauthorized use of controlled substances or other habit-forming legend drugs.
- Petitioner shall not take any mood-altering drug which has not been prescribed for him.
- Petitioner shall immediately inform the Board in writing (by email or fax) of all medications prescribed for him, stating the name of the drug, the number and strength of the doses prescribed, the dosage regimen and the name and registration number of the prescriber.
- The Petitioner shall submit a urine specimen, serum specimen or hair sample when requested by the Board or any agent of the Board of Pharmacy.
- The Petitioner’s access to controlled medications shall be monitored.
- The Petitioner is not authorized to work in a supervisory role.
- The Petitioner is not authorized to work more than fifty (50) hours per week.
- Petitioner shall keep the Board informed at all times as to place of his employment as a Pharmacist and any change in residential address.
- Petitioner shall submit a written quarterly report (on a form prescribed by the Board) to the Board, due the first week of January, April, July, and October, detailing his personal and professional well-being.

The Petitioner shall not be placed on the agenda on this matter until at least one (1) year from the date of this Order.

This ORDER OF THE BOARD is effective immediately. A certified copy of this ORDER shall be served on the Petitioner and maintained in the office of the Board.






